

**REGULAR MEETING

County Manager Les Montoya submitted for approval Project Management No. 06-PT-63-087 for the amount of \$9,000.00 S.T.E.P. is Selective Traffic Enforcement Program overtime to conduct enforcement in high crash locations and conduct stops related to alcohol.

**5. AGREEMENT BETWEEN COUNTY AND ULIBARRI AUTO SALVAGE FOR STORAGE OF PENA PROPERTY**

Planning & Zoning Supervisor Alex Tafoya informed the Commission that David Ulibarri of Ulibarri Auto Salvage agreed to store items that are to be removed from the Vince Pena property on Hot Springs Blvd. as per court order issued by the District Court. These items include mobile home trailers, truck bodies and parts, automobile bodies and parts, appliances, metal and other items. Mr. Ulibarri has indicated a monthly lease amount of \$475.00 for terms yet to be determined.

Mr. Tafoya requested approval of the lease agreement and monthly lease amount.

County Attorney Jesus Lopez explained that a Default Judgment was filed against Mr. Pena and explained what the Default Judgment consisted of.

**6. RESOLUTION EXTENDING FRANCHISE ORDINANCE BETWEEN SAN MIGUEL COUNTY AND FARMER'S ELECTRIC COOPERATIVE, INC.**

Planning & Zoning Supervisor Alex Tafoya informed the Commission that San Miguel County Ordinance No. SMC-12-14-04-FRANCHISE, grants to Farmer's Electric Cooperative, Inc., a franchise to operate within San Miguel County. The Ordinance has a one (1) year term and expires in January 2006. In order to continue the franchise it is necessary to extend the term for an additional year.

Mr. Tafoya requested the Commission consider adopting Resolution No. 01-09-06-FRANCHISE, extending the term of Ordinance No. SMC-12-14-04-FRANCHISE for an additional year.

**7. RESOLUTION IMPOSING A NON-PROHIBITIVE LICENSE TAX FEE**

Planning & Zoning Supervisor Alex Tafoya informed the Commission That New Mexico State Statute, Sections 7-24-2; 7-24-3; 7-24-4; and 7-24-5 empowers counties composing local option districts to adopt a resolution imposing an annual, non-prohibitive license tax. Such a tax can be imposed upon the "privileges of persons holding state license under the provisions of the Liquor Control Act to operate within such counties outside of the municipalities that are local option districts, as retailers, dispensers, canopy licenses, restaurant licenses or club licenses."

These sections provide that such a license tax fee cannot exceed two hundred fifty dollars (\$250.00) and also provide for the license tax period to begin July 1<sup>st</sup> of each year and end on June 30<sup>th</sup> of the following year. Such a resolution imposing a license tax fee must be adopted on or before the first day of June each year.

Mr. Tafoya requested the Commission review Resolution No. 01-09-06-PZ; adopt the resolution as authorized by State Statute.

Motion made by Commissioner David Salazar to approve Resolution No. 01-09-06-PZ as requested. Second by Commissioner Kenneth C. Medina and Vice-Chairman Hugh H. Ley. Motion carried.

**8. REQUEST FOR OUT OF STATE TRAVEL TO TULSA, OKLAHOMA FOR GILBERT ALMANZA JR., SECTION 8 HOUSING ADMINISTRATOR TO ATTEND THE SOUTHWEST NATIONAL ASSOCIATION OF HOUSING AND RE DEVELOPMENT OFFICIALS (NAHRO) CONFERENCE**

Section 8 Housing Director Gilbert Almanza requested approval to attend the Southwest NAHRO Conference in Tulsa Oklahoma.

Mr. Almanza informed the Commission that he had been appointed as a committee member and requested approval for out of state travel.

Medina to approve out of state travel for Section 8 Housing Director Gilbert Almanza to attend the Southwest National Association of Housing and re-development Officials Conference in Tulsa, Oklahoma as requested . **9. RENEWAL CONTRACT FOR INMATE CONFINEMENT, BY AND BETWEEN MORA COUNTY, NEW MEXICO AND SAN MIGUEL COUNTY, NEW MEXICO**

Warden/Facility Administrator Patrick Snedeker submitted for review and approval Renewal Contract for Inmate Confinement between Mora County and San Miguel County.

Mr. Snedeker informed the Commission that the Renewal Contract for Inmate Confinement between Mora County and San Miguel County for the housing, custody, and care of Mora County inmates has been approved by the Mora County Commission. The rate for each inmate is \$65.00 per inmate per day.

Motion made by Vice-Chairman Hugh H. Ley to approve Renewal Contract for Inmate Confinement between Mora County and San Miguel County as requested. Second by Commissioner Kenneth C. Medina. Motion carried.

County Manager Les Montoya informed the Commission that Mora County has fallen behind in their payments for Inmate Confinement and that he would be sending out a letter to Mora County regarding that matter.

**10. EXTENSION AGREEMENT-CONFINEMENT OF PRISONERS, SAN MIGUEL COUNTY, NM AND THE TOWN OF TAOS, NM**

Warden/Facility Administrator Patrick Snedeker submitted for review and approval Extension Agreement- Confinement of Prisoners between San Miguel County and the Town of Taos.

Mr. Snedeker informed the Commission that the Extension Agreement- Confinement of Prisoners between San Miguel County and the Town of Taos has been approved by the Town of Taos Officials. The rate for each inmate is \$65.00 per inmate per day.

Motion made by Vice-Chairman Hugh H. Ley to approve Extension Agreement- Confinement of Prisoners between San Miguel County and the Town of Taos as requested. Second by Commissioner Kenneth C. Medina. Motion carried.

**11. ADMINISTRATIVE REGULATION NO. ADM-R-1-9-06 VEHICLE USE POLICY SETTING A REVISED VEHICLE USE POLICY FOR SAN MIGUEL COUNTY**

Safety Coordinator Manuel M. Chavez submitted for review and approval the Administrative Regulation No. ADM-R-9-06 Vehicle Use Policy a revised vehicle use policy for San Miguel County.

Mr. Chavez informed the Commission that the new “Vehicle Use Policy” was reviewed and discussed by the San Miguel County Safety Committee as well as the County Manager.

The new policy will reflect the intent to protect the County’s human capital and financial resources from accidental and intentional loss. This program will save lives, decrease injuries, minimize County costs and potential liabilities and increase productivity and efficiency.

Commissioner David R. Salazar asked for clarifications regarding the mechanisms supporting the policy.

Mr. Montoya explained the mechanisms of the policy and how the vehicle maintenance logs would be worked out. Discussion ensued.

Motion made by Commissioner Kenneth C. Medina to approve Administrative Regulation No. ADM-R-9-06 Vehicle Use Policy a revised vehicle use policy for San Miguel County as presented. Second by Commissioner David R. Salazar. Motion carried.

**12. 01-09-2006-FMA RESOLUTION ALLOWING THE CABO LUCERO FIRE DEPARTMENT TO APPLY FOR FINANCING FROM THE NEW MEXICO FINANCE AUTHORITY IN THE AMOUNT OF \$186,000.00 FOR CONSTRUCTION OF A SUBSTATION IN THE SAN GERONIMO**

Fire Marshal Dan Wright informed the Commission that the Cabo Lucero Fire Department acquired property for the construction of a substation financing in the amount of \$186,000.00 for the construction.

Mr. Wright requested the Commission review and approve 01-09-2006 FMA Resolution allowing the Cabo Lucero Fire Department to apply for financing from the New Mexico Finance Authority in the Amount of \$186,000.00 for construction of a substation in the San Geronimo area. Discussion ensued.

Motion made by Commissioner David R. **13. MONTHLY REPORT FOR THE PUBLIC WORKS DIVISION FOR THE MONTH OF DECEMBER 2005**

Public Works Division Supervisor Harold Garcia went over the monthly report for the month of December 2005 and answered questions from the Commission.

Commissioner David R. Salazar expressed his concerns regarding the solid waste convenience center in Bernal which has become a big mess, with trash flying around because no one is watching over the facility.

Chairman LeRoy H. Garcia suggested that the problem might be solved if someone worked at the facility for four (4) hours a day or provide trash pickup for the Bernal area. Commissioner Garcia also asked the County Manager Les Montoya what would be the cost to have a person man the convenience center.

Mr. Montoya's response was that the cost would be approximately \$17,000.00 for an annual salary.

Public Works Division Supervisor Harold Garcia informed the Commission that he would train a person from the HELP Office and he would send an experienced worker to the Bernal site.

Chairman LeRoy H. Garcia reiterated to Mr. Garcia that under **no** circumstances that **any** of the convenience sites close for any holiday, that **all** convenience centers must remain open for eight (8) hours a day. Commissioner Garcia stated that he received complaints regarding the closing of the convenience sites during the holidays.

**14. REQUEST FOR PROPOSALS FOR ELECTRICAL SERVICES**

Public Works Division Supervisor Harold Garcia informed the Commission that the Public Works and Detention Center have a need for day to day electrical services from a licensed electrician related to building facilities with these two divisions.

Mr. Garcia requested authorization to proceed in advertising for a Request for Proposals for electrical services. Mr. Garcia informed the Commission that approximately \$15,000.00 was spent for electrical services for the year of 2005.

Motion made by Commissioner Kenneth C. Medina to authorize staff to proceed to advertise for Request for Proposals for Electrical Services. Second by Vice-Chairman Hugh H. Ley. Motion carried.

**15. REQUEST FOR PROPOSALS FOR PLUMBING SERVICES**

Public Works Division Supervisor Harold Garcia informed the Commission that the Public Works and Detention Center have a need for day to day plumbing services from a licensed plumber related to building facilities with these two divisions.

Mr. Garcia requested authorization to proceed in advertising for a Request for Proposals for plumbing services.

Motion made by Commissioner Kenneth C. Medina to authorize staff to proceed to advertise for Request for Proposals for Plumbing Services. Second by Vice-Chairman Hugh H. Ley. Motion carried.

**16. AGREEMENT BETWEEN SAN MIGUEL COUNTY AND OUR LADY OF SORROWS PARISH FOR USE OF PARKING LOT OWNED BY OUR LADY OF SORROWS LOCATED ON VALENCIA STREET**

Public Works Division Supervisor Harold Garcia submitted for approval an Agreement between San Miguel County and Our Lady of Sorrows Parish for use of the parking lot owned by our Lady of Sorrows located on Valencia Street.

County Manager Les Montoya informed the Commission that in exchange the County would be responsible for snow removal for the parking lot on Valencia Street.

Motion made by Commissioner Kenneth C. Medina to approve Agreement between San Miguel County and Our Lady of Sorrows Parish for use of parking lot owned by our Lady of Sorrows located on Valencia Street. Second by Commissioner Kenneth C. Medina. Motion carried.



**17. MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN QUAY COUNTY, HARDING COUNTY AND SAN MIGUEL COUNTY CONCERNING MAINTENANCE OF THE GIS DATA BASE FOR THE CONSOLIDATED DISPATCH CENTER IN TUCUMCARI**

County Manager Les Montoya informed the Commission that the MOU is required and recommended by the City of Tatum Police Department. The Tatum Police Department received an E-911 Network and Database grant to equip and provide a Regional Public Safety Answering Points (PSAP'S) Enhanced 911 landline service and wireless Phase I and II service. The City of Tatum is presenting the MOU as prepared to Harding County and San Miguel County.

Mr. Montoya recommended the Commission review and approve the MOU between Quay County, Harding County and San Miguel County.

County Manager Les Montoya informed the Commission that this MOU is proposed to define the responsibility of each entity as it pertains to the use of legislative funds to improve or maintain the Las Vegas Senior Citizens Center

Mr. Montoya stated that San Miguel County will serve as a fiscal agent; the County has no interest in the building or decision making as far as improvements.

James Garcia, Director of the San Miguel Senior Citizens Center requested the Commission consider approving the MOU as presented. Discussion ensued.
