PRESENTATION REGARDING THE OFFICE OF EMERGENCY MANAGEMENT OPERATION PLANS AND PREPAREDNESS BASED ON EXISTING CONDITION FACED TODAY IN SAN MIGUEL COUNTY BY TIM GALLEGOS, CHIEF OF POLICE

Las Vegas Capitan William Cruz gave a presentation about the Las Vegas-San Miguel County Emergency Management Office and the area's disaster plan. Discussion ensued.

Captain Cruz updated the Commission on different exercises that are performed for emergency preparedness. Discussion ensued.

1. COUNTY TREASURER'S MONTHLY REPORT

County Treasurer Alfonso Ortiz went over the County Treasurer's Monthly Report for the month of March 2006.

PRESENTATION FROM THE PUBLIC SERVICE COMPANY OF NEW MEXICO FOR THE SL AND VS LINE UPGRADE PROJECT BY ROBERT CASTILLO, PNM

Robert Castillo, Northern Regent Director for PNM introduced himself to the County Commissioners.

Richard Precek and Emilie Dohleman from the Public Service Company gave a presentation regarding the SL and VS Electric Transmission Line Improvement Project. Mr. Precek went over the purpose of the project, construction process, phase raising, bayoneted truss and construction schedule. Discussion ensued.

2. PETITION TO DISCONTINUE A PORTION OF COUNTY ROAD B-48

Planning & Zoning Supervisor Alex Tafoya informed the Commission that on March 10, 2006 the county conducted a public road viewing of County Road B-48 for the purpose of determining whether or not to discontinue the road as a County road. Approximately 18 people attended the road viewing and the road viewers submitted a recommendation to keep County Road B-48 as a County road.

Mr. Tafoya requested the Commission conduct a public hearing and accept public comment and review the recommendations of the road viewers and accept their recommendation.

Chairman LeRoy H. Garcia requested public comment regarding the petition to discontinue a portion of County Road B-48.

The following persons who were in favor of keeping the road open came forward:

William Gonzales spokesperson for 87 land grant members

No one came forward against keeping the road open.

Motion made by Commissioner David R. Salazar to keep County Road B-48 open and maintain said road whenever is needed. Second by Commissioner Kenneth C. Medina. Motion carried.

3. VILLAGE OF TECOLOTE ROAD DRAINAGE PROJECT-REQUEST FOR PROPOSALS FOR ENGINEERING SERVICES

Planning and Zoning Supervisor Alex Tafoya reminded the Commission that on March 30, 2006, the Community Development Council conducted its hearings for the allocation of Community Development Block Grant funds. It was determined that the County would be receiving an award of \$366,000.00 in CDBG funds for a road and drainage project in the Village of Tecolote. A preliminary engineering report was prepared for the Tecolote Road and Drainage Project, however, a final design of the project has not been prepared. It is necessary to have a final design of the project prepared so that the County can issue an invitation

Mr. Tafoya requested authorization to issue a Request for Proposals for Engineering and Design for the Tecolote Road and Drainage Project.

Commissioner David Salazar expressed his gratitude to Mr. Tafoya, Mr. Montoya and all the Commissioners for all their support for this project.

Motion made by Commissioner David Salazar to authorize staff to issue a Request for Proposals for Engineering and Design for the Tecolote Road and Drainage Project as requested. Second by Vice-Chairman Hugh H. Ley. Motion carried.

Mr. Tafoya also thanked Tecolote residents, Joe and Angela Herrera for all their help.

Mrs. Angela Herrera and Mr. Joe Herrera on behalf of the residents of Tecolote thanked all the County Commissioners.

County Manager Les Montoya invited Commissioner Salazar and the Herrera's to join the committee for the selection of the engineer. Discussion ensued.

Chairman LeRoy H. Garcia thanked Mr. Tafoya and his staff for the cleaning of the Pena property.

4. REQUEST FOR PROPOSALS-HOUSING ASSISTANCE GRANT/RIBERA HOUSING PROJECT

Planning & Zoning Supervisor Alex Tafoya submitted for approval a Notice of Request for Proposals to solicit applications to determine qualifying grantees for the use of a housing assistance grant to be awarded, loaned or distributed under the County's Affordable Housing Ordinance.

Mr. Tafoya requested the Commission review the Request for Proposals (RFP) and authorize the release of the REP for advertisement. Discussion ensued.

Motion made by Commissioner David Salazar to authorize the release of RFP for advertisement as requested. Second by Vice-Chairman Hugh H. Ley. Motion carried.

5. FAIR HOUSING POLICY

Planning & Zoning Supervisor Alex Tafoya submitted for approval the Fair Housing Policy.

Mr. Tafoya informed the Commission that the County's current Fair Housing Policy was last reviewed in September 2002 and is now three (3) years old. DFA-Local Government Division recommends that such policies be reviewed and approved every two or three years. The review and approval ensures that the County is in compliance with the various grant funding sources that are administered by DFA-Local Government Division. The language of the Fair Housing Policy has not been changed.

Motion made by Vice-Chairman Hugh H. Ley to approve the Fair Housing Policy as requested. Second by Commissioner David R. Salazar. Motion carried.

6. VOTING DELEGATE FOR ADELANTE RESOURCE CONSERVATION AND DEVELOPMENT (RC&D)

Planning & Zoning Supervisor Alex Tafoya informed the Commission that Adelante Resource Conservation and Development Council, Inc., submitted its annual report for Fiscal Year 2005 and also submitted a request for Council dues and a request for San Miguel County to appoint a voting delegate.

Mr. Tafoya requested that he be re-appointed to serve as the voting delegate for San Miguel County or a new delegate be appointed. Mr. Tafoya also requested approval for payment of yearly dues in the amount of \$75.00.

Motion made by Vice-Chairman Hugh H. Ley to re-appoint Planning and Zoning Supervisor Alex Tafoya as the voting delegate for San Miguel County and to approve payment of yearly dues in the amount of \$75.00. Second by Commissioner Susano Ortiz. Motion carried.

County Manager Les Montoya thanked Planning and Zoning Supervisor Alex Tafoya for all his efforts and hard work regarding the CDBG Grants.

7. RESOLUTION SMC -04-11-06-EM DECLARING DROUGHT CONDITIONS IN SAN MIGUEL COUNTY CONSTITUTE A DISASTER SITUATION

Fire Marshal Dan Wright submitted for approval Resolution SMC-04-11-06-EM Declaring San Miguel County Drought a Disaster.

Motion made by Vice-Chairman Hugh H. Ley to approve Resolution SMC- 04-11-06-EM Declaring San Miguel County Drought a Disaster as requested. Second by Commissioner Susano Ortiz. Motion carried.

8. RESOLUTION TO AMEND FIRE ORDINANCE TO CONFORM WITH RECOMMENDATION OF THE GOVERNOR AND TO BRING CURRENT ORDINANCE INTO COMPLIANCE WITH CHANGING STATE AND FEDERAL LAWS

Fire Marshal Dan Wright submitted for review and approval, Resolution to amend Fire Ordinance to conform with recommendation of the Governor and to bring current ordinance into compliance with changing State and Federal Laws.

Vice-Chairman Hugh H. Ley went over the changes he wanted made to the resolution. Discussion ensued.

Motion made by Vice-Chairman Hugh H. Ley to approve Resolution as amended. Second by Commissioner Susano Ortiz. Motion carried.

9. DONATION OF PROPERTY FOR A FIRE STATION IN ILFELD

Fire Marshal Dan Wright informed the Commission that Glenn Post has offered to donate one acre piece of real property to the County for the purpose of constructing a fire station. The property is located just north of San Juan/San Jose exit off I 25.

Mr. Wright requested the Commission accept the property and waive the subdivision fee of \$225.00.

Commissioner David Salazar asked Mr. Wright if he had looked into the County owned property, which is located approximately one (1) mile down the road from the property Glen Post wants to donate which has a water tank and electricity.

Mr. Wright explained that the boundary line goes right in between the two (2) fire departments. The two (2) fire departments are the El Pueblo Fire Department and the Ilfeld Fire Department. Discussion ensued.

After much discussion it was decided to table this item until the County Manager, the Fire Marshal, Commissioner Ley and Commissioner Salazar meet with the fire departments involved.

Motion made by Commissioner Susano Ortiz to table this item until the County Manager, the Fire Marshal, Commissioner Ley and Commissioner Salazar meet with the fire departments involved. Second by Vice-Chairman Hugh H. Ley. Motion carried.

Fire Marshall Dan Wright clarified the use of citations that would be issued if any of the provisions in the ordinance are violated. Discussion ensued.

10. MONTHLY REPORT FOR THE PUBLIC WORKS DIVISION FOR THE MONTH OF MARCH 2006 AND BLADING SCHEDULE FOR APRIL 2006

Public Works Division Supervisor Harold Garcia went over the monthly report for the month of March 2006 and answered questions from the Commission. Discussion ensued.

Commissioner Susano Ortiz wanted to thank Mr. Robert Gerhardt for donating material for the county road located in upper Rociada.

Vice-Chairman Hugh H. Ley thanked Public Works Supervisor Harold Garcia for the blading schedule that was provided to the Commission.

11. SOLID WASTE JOINT POWERS AGREEMENT BETWEEN SAN MIGUEL COUNTY AND GUADALUPE COUNTY FOR THE PURPOSE OF SOLID WASTE COLLECTION SERVICES IN THE VILLAGE OF TECOLOTITO IN SAN MIGUEL COUNTY

Public Works Division Supervisor Harold Garcia informed the Commission that the County experienced problems in the Village of Tecolotito with the Solid Waste Services that the County is providing. The open-top roll off containers in the area have had littering problems in that facility and along the adjoining property of the Tecolotito Land Grant.

Mr. Garcia informed the Commission that he had contacted Guadalupe County to provide assistance with their front end loader to illuminate the problem in Tecolotito.

Mr. Garcia submitted for review and approval a proposed Joint Powers Agreement between San Miguel County and Guadalupe County. The Guadalupe County would assess an amount of \$18,000.00 per year to provide the service. Discussion ensued.

Vice-Chairman Hugh H. Ley expressed his concerns regarding the solid waste fees that need to be collected if the County is extending the solid waste service. Commissioner Ley asked the County Attorney Jesus Lopez what recourse the County would have if they the residents are provided the service and refuse to pay.

County Attorney Jesus Lopez response to Commissioner's Ley question was that the County gave up no rights of enforcement under this Joint Powers Agreement regardless of who collects the fees as per the ordinance. Discussion ensued.

Mr. Lopez also explained the avenues the County could take for failure of none payment of their account. Discussion ensued.

Chairman LeRoy H. Garcia requested County Manager Les Montoya to look into getting a part-time worker for the Solid Waste Department for the new fiscal year. Discussion ensued.

County Manager Les Montoya also informed the Commission that he is looking to purchase transport equipment for transporting solid waste. Discussion ensued.

Commissioner Ley and Commissioner Salazar feel that if the County is extending solid waste services to the residents all should pay for the service.

County Attorney Jesus Lopez suggested the Commission direct the County Manager and the Finance Division Supervisor to get a listing of all residents that are delinquent for the next meeting.

Vice-Chairman Hugh H. Ley wants all outstanding delinquencies addressed and if the account is past due to take the proper measures as to file in court. Discussion ensued.

Motion made by Commissioner David R. Salazar to approve Joint Powers Agreement between San Miguel County and Guadalupe County as requested. Second by Vice-Chairman Hugh H. Ley. Motion carried.

12. LOCAL LAW ENFORCEMENT PROTECTION FUND

County Sheriff Chris Najar submitted for approval the Local Law Enforcement Protection Fund.

Annual Grant awarded to New Mexico Law Enforcement Agencies in the amount of \$24,000.00. Grant is used to pay for Sheriff's Patrol Units through the New Mexico Financial Authority.
