4. REQUEST TO RE-ALLOCATE FUNDING FROM WITHIN THE DWI GRANT*

DWI Coordinator Wendy Armijo informed the Commission the San Miguel County DWI Planning Council is requesting that a portion of the amount of \$24,000.00 be re-allocated from DWI Treatment Component and placed in the DWI Prevention Component. The purpose of the re-allocation is to provide the funding needed to acquire a contractual "DWI Prevention Specialist". Duties for the stated position include but are not limited to the implementation of the Protecting You Protecting ME science-based program, in all San Miguel County elementary schools, grades K-5. Coordination and implementation of other science/research based programs to be provided and/ or conducted in school, community and local organization, Media, public service, program/ community liaison.

5. REQUEST TO APPROVE OUT-OF-STATE TRAVEL TO ATTEND "PREVENTION DAY" PROVIDED BY THE CENTER FOR SUBSTANCE ABUSE PREVENTION (CSAP) AND THE SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION (SAMHASA)*

The event will focus on Underage Drinking-Communities Connecting and Collaborating. The one-day event is to take place on February 12, 2007 and will be held in Washington D.C. In order to facilitate and encourage participation in Prevention Day, SAMSHA/CSAP will pay airfare, lodging and per diem expenses.

7. CONTRACT FOR INMATE CONFINEMENT-TAOS COUNTY, NEW MEXICO AND SAN MIGUEL COUNTY, NEW MEXICO*

Warden / Facility Administrator Patrick Snedeker informed the Commission the contract for Inmate Confinement by and between Taos County, New Mexico and San Miguel County, New Mexico for the confinement and care of Taos County inmates, at the San Miguel County Detention Center is presented. The contract reflects an agreed upon fee of \$50.00 per inmate, per day, while housed at the San Miguel County Detention Center.

Mr. Snedeker submitted for approval the contract for inmate confinement-Taos County, and San Miguel County, New Mexico.

Motion made by Vice-Chairman Kenneth C. Medina to approve the agreement between Taos and San Miguel County, New Mexico. Second by Commissioner David Salazar. Motion carried.

8. A LEASE AGREEMENT WITH THE SAN MIGUEL COUNTY SHERIFF'S DEPARTMENT AND THE PECOS INDEPENDENT SCHOOL DISTRICT. THIS LEASE AGREEMENT WILL ALLOW THE SAN MIGUEL COUNTY TO RENT SCHOOL PROPERTY, UPON WHICH A COUNTY OUTSIDE MOBILE HOME IS PLACED*

Section 8 Housing Director Gilbert Almanza, Jr. informed the Commission the agreement between the Schools and the County was to not charge rent for the first two years because of the ground work and set-up necessary in setting up the mobile home for residence. San Miguel County would be responsible for utility costs incurred by the residence as long as the residence is on school property. Now the school is proposing a Lease Agreement that would require San Miguel County to pay \$150.00/ per month for lease of school property.

Mr. Almanza submitted for approval the agreement authorizing San Miguel County Sheriff's Department to sign the agreement.

Motion made by Vice-Chairman Kenneth C. Medina to approve the agreement and authorize San Miguel county Sheriff's Department to sign the agreement. Second by Commissioner David Salazar. Motion carried.

This backhoe was recently returned to Caterpillar. the Public Works Division recently advertised for bids for a 60-month lease of a backhoe with the option to purchase after 60 months. There was one bid submitted by Wagner Equipment Company in the amount of \$1,035.00 per month lease.

Mr. Garcia submitted for approval the bid submitted by Wagner Equipment Company and authorizes a lease agreement for execution by San Miguel County.

Bids were received and opened on October 13, 2006 and November 8, 2006, and the Commission rejected the high bid and authorized staff to seek the best obtainable price for the building project.
