## 2. FISCAL YEAR 2007 HOMELAND SECURITY GRANT PROGRAM APPLICATION\*

Lt. Eugene Garcia could not make it to the meeting so County Manager Les Montoya informed the Commission the #1 funding request -Established a five County Public Safety Information Center, in the amount of \$486,587.00. The purpose is to coordinate the Law Enforcement, Fire and EMS action throughout the Fire County region. This project will provide Records Management, Computer Aided Dispatch and Jail Management for Public Safety Agencies located in San Miguel, Colfax, Harding, Union and Mora Counties with the ability to share data regionally. This project can provide additional Officer, Fireman, and EMS safety though the regional CAD monitoring and improve conviction rates and protect the agencies using report generation tolls included in the RMS system. Investigative tools available in the system will assist local jurisdictions to prevent, protect, respond to and recover from a terrorist incident, disaster or emergency.

#2-Interoporable Communications Equipment in the amount of \$300,000.00. This project dovetails with the San Miguel/Las Vegas upgrade of Computer Aided Dispatch and Records Management Systems and the implementation of mobile computing purchased with 2004/2005 monies. Provide a wireless network for the County along the I-25 corridor.

Record will show that all Commissioners are in agreement with pursuing the agreement.

## 3. HOUSE MEMORIAL 48<sup>TH</sup> LEGISLATIVE SESSION STATEOF NEW MEXICO FIRST SESSION 2007, ESTABLISHMENT OF A PILOT PROJECT WITHIN SAN MIGUEL COUNTY, FOR AFFORDABLE HEALTH CARE SERVICES FOR UNINSURED PERSONS, WITHOUT INCREASING GOVERNMENT CONTRIBUTIONS\*

Rita Torres, CEO of Management Team Solutions, Inc. as well as Lawrence Medina informed the Commission that on October 10, 2006 Ms. Torres provided a presentation to the San Miguel County Commission specific to affordable health care services for uninsured persons within San Miguel County. Ms. Torres shall provide information

specific to the current progress of this pilot program initiative, including a House Memorial Resolution specific to the program.

## 4. RESOLUTION EXTENDING FRANCHISE ORDINANCE BETWEEN FARMER'S ELECTRIC COOPERATIVE AND SAN MIGUEL COUNTY\*

Planning and Zoning Supervisor Alex Tafoya informed the Commission that San Miguel County Ordinance No. SMC-12-14-04-FRANCHISE grants to Farmers Electric Cooperative a franchise to operate within San Miguel County. The Ordinance has a term of one (1) year and is renewed on a yearly basis. Farmers' Electric Cooperative has advised that it wishes to renew the Franchise Ordinance for another one year period.

The cost of detaining an inmate, at a rate of \$53.00 Dollars per inmate for each partial day (less than (12) hours confinement), and other provisions remain pursuant to said contract. The Extension Agreement was approved by the Las Vegas City Council on March 7, 2007.
