3. RESOLUTION OPPOSING PETITION; WQCC 06-09 TO NOMINATE THE WATERS OF THE INVENTORIED ROADLESS AREAS OF THE PECOS WATERSHED AS OUT STANDING NATIONAL RESOURCE WATERS*

County Manager Les Montoya informed the Commission that during the March 2007 Commission Meeting, the Forest Guardians presented a resolution in support of said action. County residents opposed to the proposal have submitted a resolution opposing action.

Mr. Eric Roybal informed the Commission of the problems that could happen if the Commission would approve the resolution that was presented at the March 2007 Commission Meeting.

Mr. James Atencio one of the many residents to be effected opposed the Forest Guardians resolution. He expressed concern for future cattle grazing in that area.

Mr. Roybal submitted for approval Resolution No. 05-08-2007-CM opposing the Forest Guardian invitation.

4. RESOLUTION NO. 05-08-07-SMC-LEDA, PROPOSING THE ADOPTION OF AN ORDINANCE ADOPTING AN ECONOMIC DEVELOPMENT PLAN PURSUANT TO THE LOCAL ECONOMIC DEVELOPMENT ACT, ESTABLISHING APPLICATION REQUIRMENTS, AND AUTHORIZING SAN MIGUEL COUNTY TO ENTER INTO JOINT POWER AGREEMENTS WITH LOCAL GOVERNMENT ENTITIES AND DEVELOPMENT AGREEMENTS WITH NON-PROFIT ENTITIES. (THE TITLE AND A GENERAL SUMMARY OF THE PROPOSED ORDINANCE WILL BE PUBLISHED AS REQUIRED BY LAW, AND AFTER CONDUCTING A PUBLIC HEARING AT THE JUNE 12 REGULAR MONTHLY MEETING, THE COUNTY COMMISSION MAY ADOPT THE ORDINANCE AT THAT TIME).*

County Manager Les Montoya and County Attorney Jesus L. Lopez informed the Commission Local Economic Development Act requires the proposed ordinance be adopted before the County may act to adopt a Development Agreement with the Las Vegas/ San Miguel County Economic Development Corporation, or otherwise implement the purposes of the LEDA regarding the Medite Property. (The Development Agreement was discussed at length by the County Commission at its Special Meeting held on April 17, 2007 at the County Manager's conference room).

Mr. Montoya submitted for approval Resolution No. 05-08-07-SMC-LEDA proposing the adoption of the aforesaid ordinance at the June 12, 2007 Regular Meeting.

5. DISCUSSION OF RULES AND RELATING TO PARLIAMENTARY PROCEDURE, AS IT PERTAINS TO COUNTY COMMISSION MEETINGS.*

County Manager Les Montoya informed the Commission that Chairman Hugh Ley would like to discuss the information of parliamentary procedure that would apply to the Board of County Commissioners when holding County Commission Meetings.

6. JOB DESCRIPTION FOR BUREAU OF ELECTIONS SUPERVISOR*

Chief Deputy Melanie Rivera informed the Commission that the State Legislature recently funded a position to establish a Bureau of Elections Division within the County Clerk's Office. This Job description is for the Bureau of Elections Supervisor.

7. NM AGING LONG-TERM SERVICES DEPARTMENT CONTRACT NO. 2007-2428 (\$96,000.00)*

Planning and Zoning Supervisor Alex Tafoya informed the Commission that San Miguel County serves as fiscal agent and grant administrator for certain NM Aging and Long-Term Services Department contracts for the Senior Citizens Centers within the County. San Miguel County has received Contract No. 2007-2428 which provides \$ 96,000.00 to purchase and install meals equipment for the Las Vegas/ San Miguel Senior Centers located in San Miguel County. In order to access the funds it is necessary to review and accept the contract.

Mr. Tafoya submitted for review and approval Contract No. 2007-2428, authorizing Commission Chairman Hugh H. Ley to sign the Contract.

8. GRANT AGREEMENT FOR 2007 LEGISLATIVE GENERAL FUND PROJECTS*

Planning and Zoning Supervisor informed the Commission that San Miguel County has received its first grant agreement for projects under the 2007 Legislative General Fund. Included in this grant agreement are seventeen (17) projects totaling \$1,998,800.00. In order to access the funds it is necessary to review and accept the grant agreement.

Mr. Tafoya submitted for approval the Grant Agreement for 2007 Legislative General Fund Projects.

9. RESOLUTION NO. 05-08-2007-FM ESTABLISHING FACTS REQUIRED BY THE PUBLIC REGULATION COMMISSION FOR AN APPLICATION FOR A CERTIFICATE OF NECESSITY AND ALLOWING THE COUNTY MANAGER TO APPLY FOR THAT CERTIFICATE AS REQUESTED BY PRC COUNSEL*

Fire Chief Dan Wright informed the Commission that in order to apply for a certificate of necessity for an ambulance service it must be established either with documents or by resolution when the County was founded how the County is adequately insured and the person designated to submit the application on behalf of the County.

Mr. Wright submitted for approval Resolution No. 05-08-2007-FM.

10. ACCEPTING DONATION OF A PIECE OF PROPERTY FROM THE SAPELLO/ROCIADA FIRE COMPANY, A 501C3 CORPORATION TO ALLOW CONSTRUCTION OF THE FIRE STATION SINCE THE PROPERTY MUST BE OWNED BY THE COUNTY FOR THE STATE FIRE MARSHAL TO FUND THE STATION*

Fire Chief Dan Wright informed the Commission that the Biophilia Foundation donated a 1.957 acre piece of property to the Sapello/Rociada Fire Company for the construction of a fire station. Ownership of that property now needs to be transferred to the County of San Miguel so construction on the station can begin. The location has been approved by the State Fire Marshal.

Mr. Wright submitted for approval the donation of the property from the Sapello/Rociada Fire Company.

Motion made by Commissioner Albert J. Padilla to accept the donation of property from the Sapello/Rociada Fire Company. Second by Commissioner June J. Garcia. Motion carried.

11. ACCEPTANCE OF GRANT MONIES RECEIVED FROM THE STATE FIRE MARSHAL'S GRANT PROGRAM IN THE AMOUNT OF \$180,000.00 FOR LA PLACITA FIRE DEPARTMENT AND AUTHORIZATION TO PURCHASE A FIRE TRUCK USING THOSE FUNDS*

Fire Chief Dan Wright informed the Commission La Placita Fire Department submitted an application for the grant program as previously authorized by the Board of County Commissioners and were notified that the grant was awarded. Specification for the vehicle were submitted to the State Fire Marshal and approved. The vehicle is available for purchase off a contract with Sandoval County for \$247,978.00. The Department has the additional money available.

Mr. Wright submitted for approval the acceptance of the grant funds and the purchase of the fire truck.

12. INTER-GOVERNMENT PROFESSIONAL SERVICES AGREEMENT NM DEPARTMENT OF PUBLIC SAFETY AND SAN MIGUEL COUNTY DETENTION CENTER-AUTOMATED FINGERPRINT IDENTIFICATION SYSTEM*

Warden/Facility Administrator informed the Commission that the NM Department of Public Safety Law Enforcement Records Bureau serves as the State Central Repository for criminal history. As such, agencies are required by State statute to submit fingerprint impressions and photographs for all persons arrested for felony, misdemeanor, and DWI offenses. The NM Department of Public Safety is entering into an Inter-Governmental Professional Services Agreement with the San Miguel County Detention Center, to provide a new Automated Fingerprint Identification System, along with maintenance of the machine and equipment agreement, at no cost. The term of the agreement is until June 30, 2011 (4-years).

Mr. Snedeker submitted for approval the Inter-Governmental Professional Services Agreement between the NM Department of Public Safety and San Miguel County.

Motion made by Vice-Chairman Kenneth C. Medina to approve the agreement between the NM Department of Public Safety and San Miguel County. Second by Commissioner June J Garcia. Motion carried.

13. (FY07-08) NM DEPARTMENT OF TRANSPORTATION, COMMUNITY DWI (CDWI) GRANT APPLICATION*

DWI Coordinator Wendy Armijo informed the Commission that San Miguel County DWI Planning Council continues to receive Community DWI Grant funds. The identified funding is a result of court fees collected from DWI convictions within San Miguel County. Its purpose is to undertake activities that will impact the DWI Problem in our County through the use of prevention/education and enforcement. A total of \$19,989.75 has been appropriated in CDWI funds for FY 07-08.

The San Miguel County DWI Planning Council in its strategic planning process has identified the need for the complementation of a transportation system that would allow citizens of the community and others an alternative to driving drunk. The program has collaborated their efforts with the City of Las Vegas Transportation Department to provide such a service.

Ms. Armijo submitted for approval the application of FY 07-08 Community DWI-CDWI Grant Funds.

Motion made by Chairman Hugh H. Ley to table the item and discuss it at a later meeting.

14. RATIFICATION OF DWI PREVENTION SPECIALIST (CONTRACT SERVICES)*

DWI Coordinator Wendy Armijo informed the Commission of the Prevention Definition: Prevention is an active process of creating healthier conditions and environments that promotes the well being of everyone (individuals, communities, families), including reducing risk behaviors and increasing protective factors.

The San Miguel County DWI Planning Council in its Strategic Planning process has identified gaps and needs within the community that exhibit a need to address unhealthy behaviors as they relate to Drinking and Driving, and/or Substance Abuse.

Thus, the program plans to employ a F/T and Contracted DWI Prevention Specialist. The stated position is responsible for the implementation of Science/Researched Based representation at all community health/career fairs and school events. Additional responsibilities include but are not limited to ongoing promotional DWI public information and public service announcements.

Ms. Armijo submitted to the Commission for approval the DWI Prevention Specialist Contract.

Motion made by Vice-Chairman Kenneth C. Medina to approve the DWI Prevention Specialist Contract. Second by Commissioner David R. Salazar. Motion carried.
