Warden Patrick W. Snedeker informed the Commission that the NM Children, Youth and Families Department and San Miguel County, are entering into a contract / agreement: to provide alternatives to detention: via the use of an electronic monitoring/ ankle bracelet for juveniles arrested in San Miguel County. The total amount of the contract is \$6,000.00 annually (\$500.00/month for 12 months).

7. MEMORANDUM OF AGREEMENT BETWEEN THE BOARD OF COUNTY COMMISSIONERS OF SAN MIGUEL COUNTY AND THE CITY OF LAS VEGAS DWI (PEE)*

DWI Coordinator Wendy Armijo informed the Commission the City of Las Vegas, and the County of San Miguel, agree to combine funds and resources in achieving a common goal of removing the DWI offender from the streets and highways of San Miguel County in an effort to reduce highway traffic accidents that are alcohol related.

In doing so, a joint application is to be provided to the NM Department of Transportation, Traffic Safety Bureau for the funding of a comprehensive Community DWI Program that reflects an integrated approach to our mutual problem of driving while intoxicated.

The San Miguel County DWI Planning Council continues to receive Community DWI Grant funds. The identified funding is a result of court fees collected from DWI conviction within San Miguel County. Its purpose is to undertake activities that will impact the DWI problem in our County through the use of prevention/ education and enforcement. A total of \$ 19,989.75 has been appropriated in CDWI for the FY 07-08.

The San Miguel County DWI Planning Council in its strategic planning process has identified the need for the implementation of a transportation system that would allow citizens of the community and other an alternative to driving drunk.

The services, referred to as the Free Safe-Ride-Home service will be available year round and will operate during all recognized governed holidays.

Ms. Armijo submitted for approval the Memorandum of Agreement between the County of San Miguel DWI Council and the City of Las Vegas.
