NEW BUSINESS:

1. COUNTY TREASURER'S MONTHLY REPORT*

County Manager Les Montoya went over the Treasurer's monthly report for the month of July 2007 and discussion ensued.

2. CDBG APPLICATION 07 PUBLIC COMMENT*

Planning and Zoning Supervisor Alex Tafoya informed the Commission that public comments are accepted throughout the year in regard to possible Community Development Block Grant projects. At least one public comment session at a County Commission meeting is acceptable under CDBG.

Chairman Hugh Ley conducted a public hearing to accept public comment in regard to possible projects for a Community Development Block Grant Application.

Mr. Tafoya had a letter from Neighborhood Association Sherwin Tanif asking for Tyson road area, space two, to be included in the ICIP plan. Mr. Tanif of is requesting a culvert system and for the road to be hot oiled, hard topped and grated in Tyson road area.

Public Works Supervisor Harold Garcia requested consideration for a Solid Waste Transfer Station to be a part of Public Works Division facility that will be built at the Northern New Mexico Industrial Business Cluster

No public comments were presented.

3. ADOPTION OF INFRASTRUCTURE CAPITAL IMPROVEMENT PLAN (ICIP) 2009-2013*

Planning and Zoning Supervisor Alex Tafoya informed the Commission that San Miguel County has developed its Infrastructure Capital Improvements Plan (ICIP) for 2009-2013. The County has solicited input in regard to projects to be included in the ICIP throughout the year. To proceed with finalizing the 2009-2013 ICIP, it is necessary to adopt the ICIP be resolution so that it can be submitted to DFA-Local Government Division. In addition, it is necessary to select the top five (5) priority projects that will be submitted for funding consideration to the Governor in the January 2008 Legislative Session.

Mr. Tafoya submitted for approval the projects listed on the attached ICIP list, and to approve the project rankings or revise the project rankings as necessary, to approve

Resolution No. 8-14-07-ICIP which adopts the 2009-2013 ICIP, and to approve the top five projects as submitted:

• Courthouse Renovation: \$500,000.00

• Public Works Division Crusher Equipment: \$140,000.00

• Tecolote Road Paving: \$700,000.00

• Northern New Mexico Business Park Infrastructure: \$1 Million

• Detention Center Phase III: \$1 Million

County Manager Les Montoya also requested that a geo-hydrological study be added to the ICIP list of projects that we have been requesting at the Federal and State level.

Motion made by Commissioner David Salazar to add the geo-hydrological study to the ICIP projects list.

Motion made by Commissioner David Salazar to approve the Adoption of Infrastructure Capital Improvement Plan (ICIP) 2009-2013 and to add the geo-hydrological study to the ICIP list.. Second by Commissioner Albert Padilla. Motion carried.

The Commission also agreed to identify the top six ICIP Projects as the County Legislative priority for 2008.

4. ECONOMIC DEVELOPMENT CAPITAL PROJECTS GRANT APPLICATION AND RESOLUTION NO. 8-14-2007-BUSINESS PARK IN SUPPORT OF THE APPLICATION*

Planning and Zoning Supervisor Alex Tafoya informed the Commission that San Miguel County is eligible to submit an application for funding to the Economic Development Capital Project Grant Program of the State of New Mexico. County Staff has determined the Solid Waste Transfer Station planned at the Northern New Mexico Business Park is a project eligible for a funding application. The County was required to submit its application by August 8, 2007 at 4:00 p.m. The application was prepared and submitted.

Mr. Tafoya submitted for ratification the Economic Development Capitol Projects Grant application in order to meet the required deadline, and to adopt Resolution No. 8-14-07-Business Park.

5. CONTRACT AGREEMENT INMATE HEALTHCARE/MANAGEMENT SERVICES, SAN MIGUEL COUNTY, NEW MEXICO AND HEALTH CARE PARTNERS SYSTEMS, LLC*

Warden/Facility Administrator Patrick W. Snedeker informed the Commission that the Contract/Agreement for Inmate Healthcare/Management Services at the San Miguel County Detention Center is presented for Commission review and approval. This is 3rd renewal of a 4 year contract term, by and between San Miguel County, New Mexico and Healthcare Partners Systems, LLC, (previously Management Team Solutions, Inc.)

Commissioner David Salazar inquired about the Electronic Pharmacy System.

San Miguel County Detention Center Medical Director Marcia Hefker advised the Commission that the Electronic Pharmacy System would benefit San Miguel County Detention Center by saving on costs for medication and a faster time frame for receiving medications needed.

Mr. Snedeker submitted for approval the Contract/Agreement.

Motion made by Vice-Chairman Kenneth C. Medina to approve the renewal of the Contract/Agreement for Inmate Healthcare/Management Services at the San Miguel County Detention Center. Second by Commissioner David Salazar. Motion carried.

6. SAN MIGUEL COUNTY, NEW MEXICO, ASSOCIATION OF COUNTIES, LUNA COMMUNITY COLLEGE, NEW MEXICO WORKFORCE CONNECTION, NORTHERN NEW MEXICO, DETENTION CENTER TRAINING ACADEMY PROGRAM*

Warden/Facility Administrator Patrick W. Snedeker informed the Commission that the New Mexico Association of Counties and Luna Community College have entered into an Agreement for the purpose of providing educational services for a New Mexico Detention Center Training Academy Program. The San Miguel County Detention Center shall join with the New Mexico Workforce Connection of Northern New Mexico, pursuant to the Workforce Investment Act; in a collaborative partnership, to provide work opportunities, meet workforce needs, and create a workforce development network, including on the job programs and training contracts for the Detention Center.

Luna Community College Vice President for Planning and Development, Mary Ward, informed the Commission of the two weeks Public Safety Seminar Program to take place August 20, 2007 through August 31, 2007. Ms. Ward also advised of the four week academy.

New Mexico Workforce Connection Regional Manager Luis Duran informed the Commission of the pre-assessments and recruiting of job seekers. The New Mexico Workforce Connection Business Consultant Carol Gonynor spoke briefly about the funding and training needs for employers to obtain employees.

Mr. Snedeker submitted for approval the agreement between New Mexico Association of Counties and Luna Community College.

Motion made by Commissioner David Salazar to approve the agreement between San Miguel County Association of Counties, Luna Community College, and the Northern New Mexico Workforce Connection. Second by June Garcia. Motion carried.

7. GOVERNOR'S BLUE RIBBON COMMISSION ON THE WELFARE OF CHILDREN OF JAILED AND INCARCERATED PARENTS, NEW MEXICO CHILDREN YOUTH AND FAMILIES DEPARTMENT SAN MIGUEL COUNTY DETENTION CENTER DEMONSTRATION PILOT SITE FOR A FAMILY VISITATION AND A CHILD RESOURCE ADVOCACY PROGRAM*

Warden/Facilitator Administrator, Patrick W. Snedeker informed the Commission that the Governor's Blue Ribbon Commission on the Welfare of Children, in concert with the New Mexico Association of Counties, solicited proposals from detention center(s) specific to a demonstration pilot site for a family visitation and a child resource advocacy program. The San Miguel County Detention Center was selected as a pilot program site and was awarded a \$50,000.00 grant. In accordance with San Miguel County Grants Policy and Procedures Administrative Regulation 06-12-07CM, a Joint Powers Agreement is being developed. Program initiation and on-going-consultation shall be provided by the New Mexico Children Youth and Families Department, the Albuquerque, New Mexico community based Peanut Butter and Jelly Program, and the New Mexico Association of Counties.

Mr. Snedeker submitted for approval the grant agreement.

Motion made by Vice Chairman Kenneth C. Medina to approve the Grant Agreement. Second by Commissioner June Garcia. Motion carried.

8. INTER-GOVERNMENTAL AGREEMENT BY AND BETWEEN SAN MIGUEL COUNTY, NEW MEXICO AND CIBOLA COUNTY, NEW MEXICO, FOR THE HOUSING AND CARE OF SAN MIGUEL COUNTY INMATES*

Warden/Administrator Patrick W. Snedeker informed the Commission of the Inter-Governmental Agreement, by and between San Miguel County, New Mexico, and Cibola County, New Mexico for the housing and care of San Miguel County inmates, at the Cibola County Detention Center for the temporary housing of high security/high risk inmates and for temporary housing of inmates during facility refurbishment process.

Mr. Snedeker advised the Commissioners that the cost of housing inmates at the Cibola County Detention Center is \$52.00 per day/per inmate.

Mr. Snedeker submitted for approval the agreement between San Miguel County and Cibola County for the housing and care of San Miguel County inmates.

Motion made by Vice-Chairman Kenneth C. Medina to approve the Inter-Governmental agreement by and between San Miguel County, New Mexico and Cibola County, New Mexico, for the housing and care of San Miguel County inmates. Second by Commissioner Albert Padilla, Motion carried.

9. MEMORANDUM OF AGREEMENT BETWEEN THE SAN MIGUEL COUNTY DWI PLANNING COUNCIL/LAS VEGAS DWI SCHOOL FACILITATOR*

San Miguel County DWI Coordinator Wendy Armijo informed the Commission that the San Miguel County DWI Planning Council is requesting that a Memorandum of Agreement be established between the San Miguel County DWI Planning Council and the Las Vegas DWI School Program provider. The purpose of the Agreement is to assure that the stated provider will financially compensate the San Miguel County DWI Planning Council \$15.00 for every offender completing the DWI School Program.

Compensation is in exchange for the use of the San Miguel County Detention Center where classes will be held. The MOA will remain in effect until services are determined to provide elsewhere.

Ms. Armijo submitted for approval the MOA as presented.

County Manager Les Montoya requested that the Commission reject the item until it is further studied and that it be discussed at a later time with Ms. Armijo
