### PRESENTATION BY MAYOR TONY ROYBAL WITH CONCERNS WITHIN THE COMMUNITY OF PECOS.

Mayor Tony Roybal expressed 2 concerns within the Community of Pecos:. The over population of stray dogs. Mayor Roybal advised that he is not equipped to maintain the over population. Mayor Roybal requested any assistance from the Commission and San Miguel County to control this problem. Secondly, Mayor Roybal advised his concern with the road entering the new Senior Center. Mayor Roybal advised that this road is a one way road and feels that the road needs to be widened to a 2 way road for safety and traffic purposes. Mayor Roybal respectfully requested consideration and any assistance in widening and paving the road. In closing, Mayor Roybal advised that the Senior Center is almost completed and invited everyone to visit.

# ASSIGNMENT OF AN AM PORTABLE ALERT TRAILER "ROADRUNNER" FROM SAN MIGUEL COUNTY/LAS VEGAS OFFICE OF EMERGENCY MANAGEMENT TO THE VILLAGE OF PECOS FIRE DEPARTMENT

Emergency Manager Dennis English advised the Commission that San Miguel County Department of OEM was awarded monies for an AM radio station 1670 which would broadcast highway advisory. In addition an AM portable alert trailer was obtained with separate radio stations AM 1640 and AM 1680. Mr. English advised that this portable alert trailer would be assigned to the Village of Pecos Fire Department for emergency notifications.

The Board of County Commissioners presented Chief Ralph Lopez a certificate assigning the AM portable alert trailer to the Village of Pecos Fire Department.

# 1. DISCUSSION OF EMERGENCY COMMUNICATION AND EMERGENCY MEDICAL SERVICES GROSS RECEIPTS TAX TO FUND OPERATIONS OF EMERGENCY MEDICAL SERVICES

County Manager Les Montoya advised the Commission that Pecos Valley Medical Center would like County Commissioners to consider taking to the voters of San Miguel County a Gross Receipts Tax Proposal to raise funding for emergency medical services in San Miguel County.

Sigred Olsen, Executive Director of the Pecos Family Medical Center that also operates the ambulance service out of the village of Pecos, spoke of the importance of keeping the ambulance service. Ms. Olsen also requested the Commission consider a gross receipts tax for the funding of this service.

Commissioner Leger asked if this service would be a county wide service or limited to the Pecos Valley.

Shelly Orem, representative of the Pecos Business Association/Assistant Fire Chief in Rowe, reminded the Commission of the packets from the Business Association in support of the Pecos Ambulance Service. Mrs. Orem also added the support from the community and business entities.

Mayor Tony Roybal advised the Commission of his support for the Pecos Ambulance Service and requested the Commission consider the proposal.

Mr. Pablo Sedillo, a representative from the office of Senator Jeff Bingaman, commented in support of the Pecos Ambulance Service.

County Attorney advised the Commission of what it may consider and what actions need to be taken if this proposal moves forward by the County Commission.

Discussion ensued.

### 5. RESOLUTION 11-10-09-CLERK, 2010 PRIMARY AND GENERAL ELECTION POLLING PLACES

(Backup)

County Clerk Melanie Y. Rivera advised the Commission that Polling Places need to be approved by the Board of County Commissioners every 2 years before the Primary and General Elections.

Mrs. Rivera advised the Commission of (2) two polling place changes, Precinct 14a from the Trujillo School House to the home of Mr. Ben Martinez and Precinct 22 from the home of Victor Ortiz to the Rowe Fire Station.

Mrs. Rivera requested approval of Resolution No. 11-10-09-CLERK.

### 6. SELF-SUPPORTING COMMUNICATIONS TOWER - APPLICATION CU-0226 (Backup)

Planning and Zoning Supervisor Alex Tafoya advised the Commission that on September 23, 2009, San Miguel County Planning and Zoning Commission reviewed Application CU-0226 submitted by ENMR-Plateau for a conditional use permit to construct a 190' telecommunications tower on property owned by Leroy J. Ramirez Limited Partnership #3 in the vicinity of Lower Rociada. A public hearing was conducted and evidence and testimony were accepted. Planning and Zoning Commission voted to recommend approval of the application, said recommendation is presented the Board of County Commissioners under Resolution No. PZ-231.

Mr. Tafoya advised that under Ordinance No. SMC-10-09-2001-PZ, the Commission should hear the application de novo at a public hearing and upon conclusion of the public hearing: (1) make and render a decision with findings of fact to either grant or deny the application; and (2) not later than twenty (20) days after the conclusion of the public hearing reduce the decision to writing and serve the decision to applicant by certified mail.

Mr. Tafoya requested the Commission hear Application CU-0226; conduct a public hearing on application; make and render a decision to either grant or deny the application; render decision in writing and serve decision to applicant by certified mail.

Chairman David Salazar opened public hearing for those in favor of proposal.

David Hughes from Plateau Communications spoke in favor of the proposal and answered questions from the Commission.

Chairman Salazar opened public comment in opposition of proposal. No comments were made.

Chairman Salazar closed public hearing.

Motion by Commissioner Albert Padilla to grant application CU-0226. Second by Commissioner Marcellino A. Ortiz. Motion carried.

### 7. CLEAN WATER STATE REVOLVING FUND - REQUIRED FORMS/WASTE WATER COLLECTION GRANT/LOAN

(Backup)

Planning and Zoning Supervisor Alex Tafoya advised the Commission that funding for the waste water collection and treatment system at the Wood Business Park is being made available through the NM Environment Department Clean Water State Revolving Fund. Required forms that need to be completed and signed are the Certification Regarding Debarment Form and the Project Description Form.

Mr. Tafoya requested the Commission authorize County Manager Les Montoya to sign the forms.

Christino Griego from the Sapello spoke briefly about his letter submitted to Chairman David R. Salazar concerning issues on Oil and Gas Drilling. Mr. Griego offered research to the Commission and requested that Ms. Pat Lehan be part of any task force pertaining to this issue.

The Board of County Commissioners directed staff to prepare a resolution supporting the ordinance that would place a moratorium on oil & gas exploration until such an ordinance addressing gas & oil exploration in San Miguel County can be imposed.

### 9. 2011 APPROPRIATIONS PROJECT REQUEST - SENATOR TOM UDALL (Backup)

Planning and Zoning Supervisor Alex Tafoya advised the Commission that the 2011 appropriations Project Requests are being accepted by the office of Senator Tom Udall. Such requests now known as "Congressionally Directed Spending" are due November 30, 2009. A project ready to go is the Courthouse/Public Works Facility Project with an estimated cost of \$527,253.59. And an additional project was identified for the San Miguel Detention Center that was presented by Warden Patrick Snedeker in the amount of 2.1 Million dollars that identified (11) eleven portions of the project.

Mr. Tafoya requested the Commission authorize staff to submit a request for funding for the Courthouse/Public Works Facility Project and the Detention Center Project to the office of Senator Tom Udall.

DWI Coordinator Wendy F. Armijo advised that at the April 16, 2009 DWI Grant Council Meeting, the DWI Grant Council gave approval to DFA to allow fiscal agents to be eligible to receive in the FY10 grant, any distribution amount over the FY09 adjusted budget (adjusted in October 2008). On Monday, August 31, 2009 the DWI Grant Council met again and changed the eligible amounts for which counties can apply. The San Miguel County DWI program is now able to apply and receive the total distribution reversion in the amount of \$6,255. The Grant Council also approved up to \$50,000 of reverted funds for a curriculum and a one week-long training for DWI Compliance Monitors across the state. The amount available is \$425 per person. The program will request an additional \$850 for the purpose of allowing the DWI Compliance Monitor and the DWI Coordinator the opportunity to attend the recommended Court Compliance Officer training. The program has applied and will receive a total of \$7,105 in reverted funds.
