7. **SMC** RESOLUTION NO. **12-08-09-WASTEWATER** LOAN **FUNDS**, PROPOSING AN ORDINANCE TO AMEND THE PREVIOUS ORDINANCE (NO. 10-14-09-WASTEWATER LOAN **FUNDS**) AUTHORIZING THE **COUNTY TO ENTER INTO A LOAN AGREEMENT** WITH THE **NEW** MEXICO ENVIRONMENT **DEPARTMENT FOR** THE **PURPOSE** OF **OBTAINING WASTEWATER** CONSTRUCTION LOAN FUNDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$95,000.00 (Backup)

County Manager Les Montoya advised the Commission that at its October meeting, the County Commission enacted Ordinance No. 10-14-09-WASTEWATER LOAN FUNDS, which became effective November 18 2009, which Ordinance authorizes a loan of \$95,000.00 from the NMED for the construction of a wastewater treatment system, but that Ordinance provides that repayment of the loan will be from the "net revenues" of the system. Because the County does not have an existing wastewater treatment system, the NMED has determined a different special funds must be dedicated for repayment of the loan. The County has available for this purpose, its capital outlay and infrastructure gross receipts taxes, and the Resolution proposes that the previous Ordinance be amended, pledging the foregoing gross receipts taxes for repayment of the loan. The Resolution provides that the amendment of the previously adopted ordinance, be adopted by the County Commission at its January 12 2010, meeting, or such other meeting as may be necessary, after notice and hearing as required by law.

Mr. Montoya requested the Commission review resolution and submitted Resolution No. 12-08-09-WASTEWATER LOAN FUNDS.

Motion to approve and adopt Resolution No. 12-08-09-WASTEWATER LOAN FUNDS by Commissioner Albert Padilla. Second by Commissioner Marcellino A. Ortiz. Motion carried.

8. SMC RESOLUTION NO. 12-08-09-NATURAL RESOURCES, PROPOSING AN ORDINANCE IMPOSING A ONE-YEAR MORATORIUM ON THE EXPLORATION AND EXTRACTION OF OIL AND GAS AND GEOTHERMAL ENERGY IN SAN MIGUEL COUNTY.

County Manager Les Montoya and County Attorney Jesus Lopez advised the Commission that at its October meeting, the County Commission directed staff to begin work on a moratorium relating to oil and gas exploration in the county. The Commission expressed concern that the County regulations in this area were very out-dated and needed to be revised and up-dated, and that during the revision and amendment process, a moratorium should be imposed. Following that direction, county staff proposes a Resolution allowing the Commission to consider at its January 2010 meeting, a moratorium ordinance.

Mr. Lopez advised the Commission of the proper legal direction the Commission must to take on this issue.
