NEW BUSINESS:

PRESENTATION BY MICHAEL ADAMS,
GOVERNORS' GRANT ADVISORY TEAM, SAN MIGUEL COUNTY
RE: AMERICAN RECOVERY AND REINVESTMENT ACT

County Manager Les Montoya introduced Mr. Michael Adams from the Governors' grant advisory team.

Mr. Adams informed the Commission that a lot is happening with the stimulus package and a lot of grant monies will be available. Mr. Adams advised that approximately 72 to 74 billion dollars are available for shovel ready projects. He also recommended a collaborative effort with all areas within the county to see what projects could be funded on the American Recovery and Reinvestment Act. Mr. Adams submitted a packet to the Commission with all this information.

Mr. Adams did advise the Commission an application can be filled out online and that he can be contacted for any assistance with grants.

Discussion ensued.

1. RESOLUTION NUMBER 05-15-09-SMC-PW FOR THE PURPOSE OF CERTIFYING THE AUTHORIZATION OF FUNDS FROM THE AMERICAN RECOVERY AND REINVESTMENT ACT (ARRA) OF 2009 BEING FUNDED BY THE UNITED STATES CONGRESS TO SAN MIGUEL COUNTY *

County Manager Les Montoya advised the Commission San Miguel County and the City of Las Vegas recently applied for Economic Stimulus Funds through the American Recovery and Reinvestment Act (ARRA) for the construction of the Cinder Road Pedestrian and Bicycle Path Improvements. Mr. Montoya also advised the Commission that San Miguel County will be receiving \$937,015.00 of Stimulus Funds through the American Recovery and Reinvestment Act (ARRA) for this project. This project must be shovel ready within 90 days after the appropriation of funds is made by San Miguel County. The Resolution and Certification being presented to the County Commission is required in order to inform the New Mexico Department of Transportation that San Miguel County will comply with the requirements set forth through the American Recovery and Reinvestment Act of 2009 for these funds being funded to San Miguel County though the U.S. Congress.

Mr. Montoya requested the Commission approve Resolution Number 05-15-09 SMC-PW and Certification for the purpose of certifying the Authorization of funds from the American Recovery and Reinvestment Act (ARRA) of 2009 being funded by the United State Congress to San Miguel County.

Motion to approve Resolution Number 05-15-09 SMC-PW and certification and submittal to the New Mexico Department of Transportation by Commissioner Albert Padilla. Second by Commissioner Marcellino A. Ortiz. Motion carried.

2. THE FISCAL YEAR 2009/10 INTERIM BUDGET WORKSHOP *

County Manager turned the meeting over to Finance Supervisor Melinda Gonzales, who informed the Commission that the County Manager and the Finance Division Supervisor met with all County Departments regarding their FY 09/10 budget requests. All requests were noted

and either incorporated in the budget and/or noted for discussion. The Commission was informed of what expenditures have been accounted for and requested consideration and input from the Commission.

The Commission reviewed the information presented from the preliminary budget and determined what action is necessary to finalize the budget and provide final approval.

Ms. Gonzales highlighted the revenues and expenditures as proposed. Ms. Gonzales also highlighted the fact that the County's projected cash balance for 2010 would exceed DFA's cash balance requirement with the budget presented.
