# 1. SAN MIGUEL COUNTY DETENTION CENTER ROOF TOP HVAC REFURBISHMENT PROJECT-RECOMMENDATION OF AWARD

Warden Patrick W. Snedeker advised the Commission that competitive sealed proposals were received specific to the San Miguel County Detention Center Roof Top HVAC Refurbishment

Project. The recommendation for San Miguel County Commission approval of award for completion of the project is Northeastern Construction Company. Bid information is attached.

Motion made by Commissioner Padilla to approve the award for project completion. Second by Commissioner Ortega. Motion carried.

#### 2. COURTHOUSE WINDOWS REPLACEMENT BID AWARD RECOMMENDATION

Planning and Zoning Supervisor Alex Tafoya advised the Commission San Miguel County received and opened bid on March 30, 2012 for the County Courthouse Windows Replacement Project. Bids were submitted by five (5) companies. Architect Kevin Balciar of Soleil West is recommending bid award to Vigil Contracting Services in the amount of \$161,397.83 for the base bid, alternate #1 and alternate #2 and applicable tax.

Motion made by Commissioner Ortega to approve the bid to Vigil Contracting Services in the amount of \$161,397.83 as per letter of bid recommendation by Architect Kevin Balciar. Second by Commissioner Padilla. Motion carried.

# 3. AMENDED INTERGOVERNMENTAL AGREEMENT BETWEEN SAN MIGUEL COUNTY AND CYFD FOR FISCAL YEAR 2013

Warden Patrick W. Snedeker advised the Commission San Miguel County Commission approval is sought for the Amended Intergovernmental Agreement between San Miguel County and CYFD specific to the Las Vegas Juvenile Justice Continuum Board for the term of July 1, 2012 thru December 31, 2012, in the amount of \$31,611.00.

# 4. REJECTION OF PROPOSALS AND OR AUTHORIZATION TO ENTER INTO NEGOTIATIONS WITH THE MOST QUALIFIED FIRM ON THE TWO PROPOSALS SUBMITTED FOR THE PLANNING AND DESIGN OF THE GUARDRAIL SAFETY PROJECT WITHIN COUNTY ROAD A-11-A IN LOS VIGILES

Public Service Foreman Harold Garcia advised the Commission staff recently advertised a Request for Proposals for Professional Design and Planning Services for the Safety Guardrail Project in Los Vigiles. Funds for this project are being made possible through the Federal Transportation Safety Projects with the New Mexico Department of Transportation.

County Manager Les W.J. Montoya advised the Commission of County Public Works financial and operational status and public services provided as requested by the County Commission.
