CALL TO ORDER AND ROLL CALL

At 1:25 o'clock p.m., Chairman Nicolas T. Leger called the meeting to order at the Commission chambers on the 2nd floor of the San Miguel County Courthouse, Las Vegas, New Mexico. Upon a call of the roll by the clerk, four of the five County Commissioners were present and a quorum was duly established and noted as follows: Chairman Nicolas T. Leger, Vice Chairman Ron R. INTRODUCTION BY COMMISSION CHAIRMAN

Thereupon, at 1:35 p.m., Commissioner Padilla moved and Commissioner Sena seconded, approval of the Resolution presented by the County Assessor, approving and imposing the property tax rates for San Miguel County, for the year 2014, and the motion was duly approved by unanimous voice vote of the County Commission.
