# MINUTES OF THE SPECIAL MEETING/PUBLIC HEARING HELD BY THE BOARD OF COUNTY COMMISSIONERS OF SAN MIGUEL COUNTY, NEW MEXICO ON WEDNESDAY, APRIL 02, 2014, BEGINNING AT 1:30 P.M. AT THE CONCHAS DAM FIRE STATION, CONCHAS DAM, NEW MEXICO

## CALL TO ORDER AND ROLL CALL

The special meeting/public hearing was called to order at 1:37 p.m. by Chairman Nicolas T. Leger.

Upon a call of the roll by County Manager Les Montoya, all Commissioners were present and a quorum duly established, as follows: Chairman Nicolas T. Leger, Vice Chairman Ron R. Ortega, and Commissioners Marcellino A. Ortiz, Arthur J. Padilla and Gilbert J. B. Sena.

### PLEDGE OF ALLEGIANCE AND SALUTATION OF NM FLAG

Joined by all in attendance, Commissioners pledged allegiance to the U.S. flag and offered their salutation to the NM state flag.

# PURPOSE AND NOTICE

Chairman Leger read the public notice for the special meeting and public hearing, as follows:

The Board of County Commissioners of San Miguel County, New Mexico, will hold and conduct a special meeting and public hearing on Wednesday, April 2, 2014, from 1:30 p.m. to 6:00 p.m. in Conchas Dam, New Mexico, at the Conchas Dame Fire Station.

The public hearing will be held for the purpose of entertaining public comment on the proposed draft oil and gas ordinance and the County's Comprehensive Plan in relation thereto, both of which are posted on the San Miguel County website. At such hearing, the County Commission will entertain public comment and receive information and data which may be presented by interested persons.

After thanking the Conchas Dam Volunteer Fire Department for making the fire station available and for hosting the meeting, Chairman Leger advised all in attendance that each person would be allowed up to 3 minutes to speak, that their names would be called from the sign-in sheet, and that after everyone spoke, if time permitted, the Commission would entertain further public comment from persons who again desired to speak.

# PUBLIC COMMENT

Whereupon, beginning at 1:47 p.m., the following 39 persons addressed the County Commission, and offered their comments relating generally to oil and gas exploration and drilling in San Miguel County, and in the eastern part of the County in particular, and relating to the formulation of a county ordinance relative thereto, and relating to the oil and gas moratorium, and to sundry other matters relating generally to the purpose of the public hearing:

# ADDITIONAL PUBLIC COMMENT

At 3:50 p.m., Chairman Leger asked if there was any person who had not yet spoken, who desired to address the County Commission. No person came forward, and Chairman Leger announced a recess.

At 4:25 p.m., following the recess, Chairman Leger reconvened the public hearing, and all five Commissioners were present.

Chairman Leger again announced the purpose of the public hearing, noting that the public hearing was being held for the purpose of entertaining public comment on the proposed oil and gas ordinance and the County's Comprehensive Plan in relation thereto, then Leger announced that the County Commission would entertain a second round of public comments.

Whereupon, beginning at 4:33 p.m., the following 13 persons again addressed the County Commission and offered their comments relating generally to oil and gas exploration and drilling in San Miguel County, and in the eastern part of the County in particular, and relating to the formulation of a county ordinance relative thereto, and to other matters relating generally to the purpose of the public hearing:

Franken, of Las Vegas, New Mexico, relating to the oil and gas moratorium, and not objecting to an extension of said moratorium for a period not to exceed 2 years.

At 5:18 p.m., Chairman Leger announced a recess, to further await the arrival of any person who had not yet addressed the Commission.

At 5:31 p.m., Chairman Leger reconvened the public hearing, with all Commissioners still in attendance. Leger then again read the public notice for the special meeting and public hearing.

### ADJOURNMENT

At 5:33 p.m., Commissioner Padilla moved and Commissioner Sena seconded, that the special meeting and public hearing be adjourned, and the motion carried by unanimous voice vote of all County Commissioners.
