Upon a call of the roll, Chairman Arthur J. Padilla, Vice-Chairman Gilbert Sena and Commissioners Rock G. Ulibarri, Marcellino A. Ortiz and Nicolas T. Leger were present, and a quorum was duly noted by Chairman Arthur J. Padilla.

Joined by staff and all in attendance, the Commissioners pledged allegiance to the U.S. flag and offered their salutation to the NM state flag.

#### APPROVAL OF AGENDA

San Miguel County Manager Les Montoya requested the Commission remove Items 10 through 14 as per not receiving State Appropriations at this point in time.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Ulibarri, the changing of the agenda was approved unanimously.

TO REGULAR ORDER, AS FOLLOWS:

## ITEM 1: ADOPTION OF SAN MIGUEL COUNTY ANIMAL CONTROL ORDINANCES AND PENALTY SCHEDULE

On October 13<sup>th</sup>, 2015, the San Miguel County Board of Commissioners approved Resolution No. 10-13-2015-SO-San Miguel County Animal Control Ordinances. This Resolution proposed the adoption of San Miguel County Ordinance No. SMC-10-100R(B)-95 providing for animal control, imposing fees, charges and fines. Therefore creating and imposing certain misdemeanor penalties for violation of the ordinance and providing an effective date and directs the County Manager to do all things necessary and proper for the adoption of said Ordinance.

Roy Montibon expressed his gratitude to the Board of County Commissioners, the Animal Welfare Coalition (AWC) and the San Miguel County Sheriff's Office for the efforts made in producing an Ordinance for Animal Control. Mr. Montibon as well expressed his concern with the limitation of amount of dogs and cats allowed per household. Many ranchers in the area have several dogs and cats used to protect livestock and limiting the amount allowed would affect them greatly. Mr. Montibon asked San Miguel County Sheriff Gary Gold since the City of Las Vegas falls within the County of San Miguel, will the Sheriff's Office have any involvement with Animal Control within the city limits, per the response of County Sheriff Gary Gold, the Sheriff's Office can assist on Animal Control calls although do not have the man power to take over Animal Control within the City but the Sheriff's Office will assist the City of Las Vegas on a case by case basis as requested by the Municipality. Mr. Montibon also asked Sheriff Gary Gold as to where the revenue from the penalties and fines from the enforcement of the Animal Control Ordinance will be placed, to which County Manager Les Montoya informed Mr. Montibon that Mid-Fiscal Year, the Sheriff's Office budget will be re-established to allow income or revenue from these fees to be used for operational costs in the Sheriff's Office.

Martina Olguin who is the Director of the Animal Welfare Coalition Pet Center in Las Vegas thanked the Sheriff's Office and spoke to the Commission on instances the AWC faces on a daily basis.

Jade Dennis who is the President of the AWC thanked the Sheriff's Office for their efforts in the Animal Control Ordinance and informed the Commission of how having an Animal Control Ordinance benefits the AWC.

Barbara Yealing who lives in the Mineral Hill area and who is in the pure bred dog show competitions told the Commission the Ordinance is one of the better Ordinances she has seen but it fails to mention anything on owners who enters dog show competitions.

Catherine Kahn informed the Commission and the Sheriff's Office that constituents that reside along I-25 and the railroad often adopt stray dogs out of the kindness of their hearts and would not necessarily be willing to pay the permit fee for stray dogs.

Justin Burkell had a concern with the wording in the Ordinance in which the amount of dogs an individual is allowed to own as well as these dogs being fenced in. Mr. Burkell's family owns a ranch is which several dogs are working dogs and is on the ranch for the purpose of herding livestock as well as protecting livestock. Under-Sheriff Anthony Madrid informed Mr. Burkell he is safe from the Ordinance as per Section 10-51-B which permits an animal to run at large if it is a working dog.

Ralph Laumbach had concerns with paying to register an animal due to the fact of the cost of having his dogs checked yearly.

Upon a motion by Commissioner Leger, and a second by Commissioner Ortiz, the adoption of the Ordinance was adopted as written.

## ITEM 2: RESOLUTION 11-10-15-CM A RESOLUTION SUPPORTING THE 2016 LEGISLATIVE PRIORITIES OF THE NEW MEXICO ASSOCIATION OF COUNTIES

The New Mexico Association of Counties (NMAC) requested each of the 33 Counties in the State of New Mexico present the 2016 NMAC Legislative Priorities to their Board of Commissioners for consideration and endorsement by resolution.

Chairman Arthur Padilla asked Commissioner Leger to inform the Commission of the priorities of the NMAC, that include restoration of Detention Center funding, supporting a state wide emergency medical services assessment, funding of a New Mexico 3D Evaluation Program and finally the Gross Receipts Tax Reform.

Upon a motion by Commissioner Leger, and a second by Commissioner Sena, the adoption of the resolution was adopted unanimously.

## ITEM 3: RESOLUTION #DWI 11-10-15 PROCLAIMING NOVEMBER 16-20, 2015 DWI AWARENESS WEEK

The New Mexico DWI Coordinators Affiliate requested all counties join to support efforts to reduce DWI crashes, DWI fatalities and use of alcohol by residents throughout the State by proclaiming the week of November 16<sup>th</sup>-20<sup>th</sup>, 2015 as DWI Awareness Week.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Ulibarri, the adoption of the resolution was adopted unanimously.

# ITEM 4: REQUEST APPROVAL TO ACCEPT SUB-GRANT AGREEMENT EMW-2015-SS-00110-S01-SAN MIGUEL COUNTY WITH THE NEW MEXICO DEPARTMENT OF HOMELAND SECURITY/EMERGENCY MANAGEMENT IN THE AMOUNT OF \$34,000.00

The New Mexico State Homeland Security Grant Program awarded San Miguel County a grant in the amount of \$34,000.00, (EMW-2015-SS-00110-S01-San Miguel County) for Project 1: EOC Computer Enhancement of Equipment.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Ulibarri, the approval of the grant award was approved unanimously.

## ITEM 5: ADMINISTRATIVE REGULATION NO. ADM-CM-11-10-15-SAN MIGUEL COUNTY PUBLIC BUILDING NAMING POLICY

In order to address the possibility of naming buildings or property owned by San Miguel County, a formal process will be in place to either approve or deny a request to do so. County staff developed an administrative regulation to address naming of public building and properties owned by San Miguel County. The criteria for a building to be named would be after the neighborhood or geographical location of where the building is located, the building purpose or use, a natural or geographic feature, or a historical figure or place. If the proposed building is to be named after an individual, the criteria would include the individual be deceased for at least one (1) year, be of high integrity, good moral character, the individual shall be a resident of the County, the individual shall have contributed outstanding civic service or charitable contributions of time or money to the County, if the individual is a former holder of political office, than the individual should be out of office for at least three (3) years.

Commissioner Sena questioned the requirements including integrity, mentioning this would be a difficult factor to consider. Commissioner Leger agreed and discussion to clarify ensued.

Further requirements of the criteria are included in the official folder which is kept within the San Miguel County Clerk's Office and is available to anyone who is interested. Discussion ensued.

Upon a motion by Commissioner Leger, and a second by Commissioner Ulibarri, the item was tabled until the Commission can further review the criteria.

#### ITEM 6: RESOLUTION NO. 11-10-15-NMFA-ROADS-1 IMPROVEMENT PROJECT-\$1.5 MILLION

San Miguel County prepared an application in the amount of \$1.5 million for financial assistance to the New Mexico Finance Authority for the financing of road and drainage

improvements to County roads. The application process required approval of the submission of the application by adoption of a resolution.

Upon a motion by Commissioner Leger, and a second by Commissioner Ulibarri, the adoption of the resolution was adopted unanimously.

#### ITEM 7: RESOLUTION NO. 11-10-15-NMFA-ROADS-2 IMPROVEMENT PROJECT-\$2 MILLION

San Miguel County prepared an application in the amount of \$1.5 million for financial assistance to the New Mexico Finance Authority for the financing of road and drainage improvements to County roads. The application process required approval of the submission of the application by adoption of a resolution.

Upon a motion by Commissioner Leger, and a second by Commissioner Sena, the adoption of the resolution was adopted unanimously.

#### ITEM 8: ADDENDUM-SUPERIOR AMBULANCE SERVICES AGREEMENT-ADDITIONAL SERVICES-SAN MIGUEL COUNTY DETENTION CENTER

San Miguel County Warden Patrick Snedeker presented to the Commission an addendum specific to the existing San Miguel County-Superior Ambulance Services Agreement which will provide additional after hours emergency response inmate health care assessment and treatment services at the San Miguel County Detention Center.

Commissioner Leger asked San Miguel County Warden Patrick Snedeker why aren't these services covered by the County's underlined contract for medical services with the medical care provider the County has on staff at the Detention facility. San Miguel County Warden Patrick Snedeker informed the Commission currently Detention Officers communicate with an off-site medical officer who works under a provider network via telephone to determine if an inmate needs additional care. Mr. Snedeker informed the Commission he is uncomfortable with those circumstances and does not want the liability and the exposure to have an additional health care provider at the Detention Center. To which Superior Ambulance would provide qualified health care personnel to assist inmates at the Detention Center.

Commissioner Ortiz asked County Manager Les Montoya if the contract with Superior Ambulance exclude the San Miguel County Detention Center in which County Manager Les Montoya informed Commissioner Ortiz that it does not exclude the Detention Center but it is only for emergency response but does not include the medical advisement that Mr. Snedeker spoke of.

San Miguel County Legal Counsel asked San Miguel County Warden Patrick Snedeker if Superior Ambulance agreed to the added language on the agreement in which Mr. Snedeker replied that Superior Ambulance agreed to the language that would hold San Miguel County harmless from claims or actions resulting from medical evaluations and treatment performed by Superior Ambulances and will add San Miguel County to its insurance policy.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Ortiz, the approval of the addendum was approved unanimously.

## ITEM 9: RATIFICATION OF THE EMNRD GRANT APPLICATION SUBMITTED BY CABO LUCERO FIRE DEPARTMENT

The Cabo Lucero Fire Department submitted a grant request for \$20,000.00 to the New Mexico Energy Minerals and Natural Resources Department for Equipment needed to prepare for wildland fire.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Sena, the approval of the grant application was approved unanimously.

#### ITEM 15: RESOLUTION NO. 11-10-15-PROCUREMENT - CDBG FUNDING

As a condition of receiving grant funds, the Community Development Block Grant Program requires entities that receive grant funds to establish and adopt a procurement policy annually by resolution approved by the governing body.

Upon a motion by Commissioner Leger, and a second by Commissioner Sena, the adoption of the resolution was adopted unanimously.

#### ITEM 16: RESOLUTION NO. 11-10-15-CITIZEN PARTICIPATION PLAN – CDBG FUNDING

As per Federal requirement, adopting a Citizen Participation Plan is a federal requirement for grantees receiving Community Development Block Grant funds. The Plan must be adopted annually by resolution.

Upon a motion by Commissioner Sena, and a second by Commissioner Ortiz, the adoption of the resolution was adopted unanimously.

# ITEM 17: RESOLUTION NO. 11-10-15-RESIDENTIAL ANIT-DISPLACEMENT-WITH EXHIBIT 1-R, RESIDENTIAL ANTI-DISPLACEMENT AND RELOCATION ASSISTANCE PLAN AND CERTIFICATION - CDBG FUNDING

The Small Cities Community Block Grant Program (CDBG) requires grantees to adopt a Residential Anti-Displacement and Relocation Assistance Plan and Certification by Resolution on an annual basis.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Sena, the adoption of the resolution was adopted unanimously.

#### ITEM 18: RESOLUTION NO. 11-10-15-SECTION 3 - CDBG FUNDING

The Community Development Block Grant Program (CDBG) requires recipients of CDBG funds to adopt a Section 3 Plan by resolution, which Plan encourages the use of small local businesses and the hiring of low income residents.

Upon a motion by Commissioner Sena, and a second by Commissioner Ulibarri, the adoption of the resolution was adopted unanimously.

#### ITEM 19: PUBLIC SERVICE DIVISION MONTHLY REPORT FOR THE MONTH OF OCTOBER 2015

San Miguel County Public Service Operations Transportation Foreman Arnold Lopez presented to the Commission the monthly report including blading of county roads and/or special projects with the county roads.

Discussion ensued.

This item was for informational purposes only.

## ITEM 20: REQUEST TO REJECT ALL BIDS AND RE-ADVERTISE FOR THE CINDER ROAD DROP OFF PROJECT

The San Miguel County Public Service Division recently held a bid opening on October 21, 2015. San Miguel County Public Service Operations Supervisor Robert Archuleta requested to reject and re-advertise all bids for the Cinder Road Drop Off Project due to a technicality.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Ortiz, the approval of the rejection of bids was approved unanimously.

## ITEM 21: ROWE FIRE STATION IMPROVEMENTS TO INCLUDE A RETAINING WALL FOR THE DRIVEWAY AND WATER STORAGE TANK INSTALLATION

San Miguel County Fire Chief Russell Pacheco requested from the Commission to advertise for improvements to be made to the Rowe Fire Station such as a retaining wall for the driveway and water storage tank installation.

Upon a motion by Commissioner Ortiz, and a second by Sena, the approval for advertisement was approved unanimously.

## ITEM 22: RIVER STEWARDSHIP PROGRAM IMPROVEMENT PROJECTS AGREEMENT WITH THE HERMIT'S PEAK WATERSHED ALLIANCE

The Hermits Peak Watershed Alliance had obtained notice to proceed to conduct a project called Gallinas Village River and Floodplain Restoration. The project will restore a 1/3 mile stretch of river and its associated flood plain in order to improve water quality and water quantity, buffer river flows from droughts and floods, and improve fish and wildlife habitat.

Commissioner Leger requested the item be tabled in the October Regular Meeting due to the fact of obtaining approval from the City of Las Vegas for the project who which in fact is the owner of the property. San Miguel County Counsel advised the Commission the City of Las Vegas authority to the County to proceed with the project.

Upon a motion by Commissioner Ortiz, and a second by Commissioner Ulibarri, the approval of the agreement was approved unanimously.

## ITEM 23: RATIFICATION OF APPROVAL OF AGREEMENT #16-CD-05-087 CDWI - SAFE RIDE HOME SERVICE

San Miguel County received the CDWI project agreement from the New Mexico Department of Transportation. The Funding comes from a \$75.00 fee imposed on convicted drunk drivers. The Community DWI Grant Fund is established to support programs, services, or activities to prevent or reduce the incidence of DWI. The grant is funded by the New Mexico Department of Transportation. The goal of the grant program is to decrease the number of injuries and fatalities in New Mexico caused by alcohol impaired drivers. The funds should complement the LDWI grant funds and address unmet needs. The San Miguel County DWI Program has traditionally used this funding to support the Safe Ride Home Service, which provided over 2,400 rides home in FY14. The amount of the award was \$8,723.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Ortiz, the ratification of approval of the agreement was approved unanimously.

#### ITEM 24: FY15 END OF YEAR REPORT FOR SAN MIGUEL COUNTY DWI PROGRAM

The San Miguel County DWI Program submitted the End of Year 2015 Report to the New Mexico Department of Finance and administration in October 2015. San Miguel County DEI Coordinator Yolanda Cruz informed the Commission the statistics on the report.

This item was for informational purposes only.

## ITEM 25: REVIEW RECOMMENDATION FOR COUNTY COMMISSION MEETING BEING BROADCAST ON THE RADIO

During the October 2015 Regular Meeting, the San Miguel County Board of Commissioners directed staff to proceed with the Request for Proposals (RFP) for the purpose for broadcasting the Board of County Commissioners meetings on the radio. The proposals were opened on October 30<sup>th</sup>, 2015. A selection committee consisting of SMCDC Warden Patrick Snedeker, Planning & Zoning Supervisor Alex Tafoya, and IT Supervisor John Tiernan reviewed the proposals on November 3<sup>rd</sup>, 2015. The committee determined that one of the proposals did not meet the scope of work set forth in the RFP. The other proposal did meet the scope of work, however, that proposal failed to identify possible conflicts of interest as required in the proposal. The vendor that submitted said proposal contacted Mr. Tiernan on November 2<sup>nd</sup>, 2015 and informed him that it was an oversight as he read the question wrong, then informed him of two employees that met the conflict of interest criteria of the RFP. Based on that, the selection committee's recommendation was to reject all proposals and re-advertise with a clarification to the "Conflict of Interest" section. The County Attorney reviewed the situation and indicated that the Conflict of Interest section "can be waived by the Commission. However, County Officials related to employees of the radio station in question should disclose this, and should not vote on the waiver issue or on the final award of the contract."

Commissioner Leger asked IT Supervisor John Tiernan if his recommendation was to reject all bids and re-advertise the RFP in which IT Supervisor John Tiernan answered yes with the clarification of the Conflict of Interest section.

Commissioner Ulibarri disclosed that his son is a low level, part time, minimum wage employee at KNMX and has been for several years but stated that it is not a conflict of interest in the RFP. Commissioner Ulibarri informed the Commission his son does not work for the bidder in the area of the bidders business; he specifically works part time in radio advertising. Commissioner Ulibarri informed the Commission himself nor his son stand to gain anything from the contract. Commissioner Ulibarri then proceeded to identify possible conflicts of interests in which the Commission may be involved in, which were, where the Commission approved \$10,000 to be given to Mainstreet and a Commissioner's spouse sits on the Board, in which Commissioner

Ulibarri stated she does a fantastic job in the community and did not see that as a conflict of interest. Another example made by Commissioner Ulibarri was that a County employee at the Detention Center, in which Commissioner Ulibarri has a great deal of respect for, has a County salary and a father who signs off on the budget and does not see that as a conflict of interest. Both circumstances Commissioner Ulibarri stated the possible conflicts of interest benefit from business with the County, in which his son does not benefit from anything and there is no conflict of interest in this contract.

Upon a motion by Commissioner Leger, and a second by Commissioner Ulibarri, the rejection of all bids and re-advertisement was approved unanimously.

## ITEM 26: SURVEY/POLLING OF SAN MIGUEL COUNTY RESIDENTS TO DETERMINE NEED FOR BROADCASTING COMMISSION MEETINGS ON THE RADIO

The San Miguel County Board of County Commissioners directed staff to look into the options for determining if there is a need to have the Commission meetings broadcasted on the radio. After researching the subject, it was determined by staff the best approach would be to have a professional polling company perform this task. This is to ensure an unbiased, scientific approach to the poll with a guaranteed accuracy and population representation. IT Supervisor John Tiernan informed the Commission he received several responses back, two companies that he reached out to did not respond, another company indicated they would not be to perform the service because they thought they wouldn't get a sample size of 400 from our County. The lowest bidder was a company out of Albuquerque with a price a little over \$10,000.

Commissioner Sena believed \$10,000 was a lot of money to spend when that amount of money can go to road improvements.

Commissioner Leger also shared the same concerns on the matter. Commissioner Leger informed the Commission his constituents in his district would much rather have road improvements as opposed to airing Commission Meetings over the radio.

Commissioner Ulibarri was opposed to spending \$10,000 on the survey of seeing if constituents are interested on Commission Meetings over the radio.

Upon a motion by Commissioner Ulibarri, and a second by Commissioner Sena, the rejection to proceed with the polling of the public was rejected unanimously.

# ITEM 27: OUT OF STATE TRAVEL FOR COMMISSIONER ROCK ULIBARRI TO ATTEND THE NACO BOARD OF DIRECTORS MEETING AND THE SAFE AND SECURE COUNTIES SYMPOSIUM IN COLORADO SPRINGS, COLORADO FROM DECEMBER 2<sup>ND</sup> THROUGH DECEMBER 4<sup>TH</sup>, 2015

Commissioner Rock Ulibarri will be traveling to Colorado Springs in December 2015 to attend the National Association of Counties Board of Directors Meeting as well as the Safe and Secure Counties Symposium.

Upon a motion by Commissioner Sena, and a second by Commissioner Ortiz, the approval of the out of state travel was approved unanimously.

#### ITEM 28: REVISE APPRAISER II MOBILE HOME JOB DESCRIPTION TO MOBILE HOME SPECIALIST

San Miguel County Assessor Patricia Gallegos presented to the Commission the revised job description for the Appraiser II H/H position. The position will no longer require field work.

Commissioner Leger asked County Assessor Patricia Gallegos if an improvement has been made to a mobile home, without the mobile home specialist going out into the field to inspect the mobile homes, how would the improvements be assessed. County Assessor Patricia Gallegos informed Commissioner Leger the Appraisers will be assessing the mobile homes in the future.

#### **ITEM 29: PERSONNEL ACTIONS OR CHANGES FOR THE MONTH OF OCTOBER 2015**

The personnel actions or changes that have taken place in San Miguel County for the month of October 2015 were submitted for ratification and approval by the San Miguel County Board of Commissioners.

Upon a motion by Commissioner Sena, and a second by Commissioner Ortiz, the ratification of the personnel actions or changes was approved unanimously.

#### ITEM 36: BUDGET ADJUSTMENT RESOLUTION 2015-11-10-F2

The first adjustment was to transfer \$20,000.00 from the General Fund (101) to Fund 215 (Road and Health Projects). This money will be utilized to obtain conceptual design estimates from our engineers for the road projects which will be tied to the new revenue bond or loan.

The next adjustment was to budget \$34,000.00 in revenue and expenditures in Fund 327 (OEM-EMW-2015-SS-0110). This is to account for the new grant agreement.

The Trementina Volunteer Fire Department (Fund 414) is in the process of purchasing a new tender/tanker. In order to purchase the unit the Trementina Volunteer Fire Department needed an additional \$64,022. The Fire Marshall Fund (Fund 403) will be providing \$40,000 to be budgeted as a transfer out of Fund 403 into Fund 414 and the Emergency Volunteer Fire Department (Fund 415) will be providing \$24,022 to be budgeted out of Fund 415 to Fund 414. These funds will not have to be repaid by the Trementina Volunteer Fire Department.

There were some adjustments that will be made to the Sapello Volunteer Fire Department (Fund 407/SR209), the Conchas Volunteer (Fund 409/SR209), Pecos Canyon Volunteer Fire Department (Fund 417/SR209), La Placitas Volunteer Fire Department (Fund 419/SR209) and the Rowe Volunteer Fire Department (Fund 420/SR209). The purpose of these adjustments is during the initial budgeting process San Miguel County Finance Division Supervisor didn't take into account the amount of revenues that would be intercepted by the New Mexico Finance

Authority. The funds intercepted are used for debt service. The debt service payments were budgeted but the incoming revenue was not. In these cases the budgeted expenditures will also be increased and posted to capital outlay.

The next adjustment is to budget \$34,000 in revenue and expenditures in Fund 327 (OEM-EMW-2015-SS-0110). This is to account for the new grant agreement.

The Trementina Volunteer Fire Department (VFD) (Fund 414) is in the process of purchasing a new tender/tanker. In order to purchase the unit the Tremenitna VFD needed an additional \$64,022. The Fire Marshall Fund (Fund 403) will be providing \$40,000 to be budgeted as a transfer out of Fund 403 into Fund 414 and the Emergency VFD (Fund 415) will be providing \$24,022 to be budgeted out of Fund 415 to Fund 414. These funds will not have to be repaid by the Trementina VFD.

Finally, there are some adjustments that will be made to the Sapello VFD (Fund 407/SR209), the Conchas VFD (Fund 409/SR209), Pecos Canyon VFD (Fund 417/SR209), La Placitas VFD (Fund 419/SR209) and the Rowe VFD (Fund 420/SR209). The purpose of these adjustments is during the initial budgeting process I didn't take into account the amount of revenues that would be intercepted by the New Mexico Finance Authority. The funds intercepted are used for debt service. The debt service payments were budgeted but the incoming revenue was not. In these cases the budgeted expenditures will also be increased and posted to capital outlay.
