#### 1. SAN MIGUEL COUNTY REGIONAL HOUSING AUTHORITY ANNUAL PLAN 2016

Acting Director of San Miguel County Regional Housing Authority Betty Valdez advised the Commission the Annual Plan is a comprehensive guide to public housing agency policies, programs, operations and strategies for meeting local housing needs and goals.

Ms. Valdez advised the Commission is "leased up" 100%.

Motion made by Commissioner Padilla to approve Annual Plan 2016. Second by Commissioner Ulibarri. Motion carried.

## 2. RECOMMENDATION BY SAN MIGUEL COUNTY MANAGER TO CONTRACT WITH ROMERO LAW FIRM, P.A. TO PROVIDE LEGAL SERVICES TO SAN MIGUEL COUNTY

SMC County Manager Les Montoya advised the Commission that recently the County Manager's Office advertised a request for proposals for legal services for San Miguel County. Four (4) responses from Legal Firms were received. Presentations by the respective Law Firms of their proposals were held on February 26, 2016. Based on the highest score of the presentations and proposals, Romero Law Firm, P.A. is the recommendation of the County Manager to the San Miguel County Board of Commissioners for award of the request for proposals for legal services.

Commissioner Leger advised that he recommended the Holt, Minert and Martinez Firm.

Vice-Chair Ulibarri advised the Commission to table the recommendation until a meeting can be held to send a full recommendation to the table.

## 3. RENEWAL OF SUPERIOR AMBULANCE SERVICE AGREEMENT WITH SAN MIGUEL COUNTY

SMC Manager Les Montoya advised the Commission San Miguel County has in place, an agreement with Superior Ambulance Services, Inc. to provide Ambulance Services in the Eastern and Western parts of San Miguel County. This agreement is scheduled for renewal by Addendum with an effective date of April 1, 2016.

Motion made by Commissioner Padilla to renew agreement with Superior Ambulance Services. Second by Commissioner Ulibarri. Motion carried.

## 4. INTERAGENCY COLLABORATIVE GRANT PARTNERSHIP-MEMORANDUM OF AGREEMENT-NORTHEAST REGIONAL EDUCATION COOPERATIVE, NEW MEXICO HIGHLANDS UNIVERSITY

SMC Planning and Zoning Alex Tafoya and Dr. James Abreu, Executive Director of the Northeast Regional Education Cooperative advised the Commission the Northeast Regional Education Cooperative is working to develop an interagency collaborative grant partnership to provide additional opportunities for seeking funding to support programs and initiatives to serve the respective constituencies of the member entities and to support the various grant opportunities that the member entities seek to obtain funds from. A draft memorandum of agreement is being submitted for consideration and approval.

#### 7. ADDENDUM TO AGREEMENT DIAMOND PEST CONTROL SERVICES

SMC Planning and Zoning Alex Tafoya advised the Commission the agreement by and between San Miguel County and Diamond Pest Control Services provides for renewal on annual basis. Diamond Pest Control Services has indicated that they wish to renew the agreement for a second year.

Motion made by Commissioner Padilla to approve agreement. Second by Commissioner Ortiz. Motion carried.

## 8. RESOLUTION NO. 03-08-16-RA01-ADDITION OF EL CERRITO LOOP, A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

SMC IT Supervisor John Tiernan advised the Commission during a routine audit of San Miguel County addressing data, it was discovered that there were a significant number of addressing issues in the village of El Cerrito. All addressed structures were addressed from County Road B28A although many of them are not directly adjacent to this road. The San Miguel County Rural Addressing staff has analyzed the situation and determined that in the interest of public safety, the best course of action is to name the road that loops onto County Road B28A as El Cerrito Loop and reassign addresses from this newly named road. Per San Miguel County Ordinance No. SMC-07-13-99-ORD-2, Section 4.1-C, to San Miguel County Ordinance No. SMC-07-13-99-ORD-2, Section 4.1-C, to San Miguel Board of County Commissioners will review and take appropriate action on road naming for, "any private road that provides access to three of more buildings and requires a name in order to promote the health, safety and welfare of the public." The San Miguel County Rural Addressing office is waiving the normal fee due to the fact that the naming is being required by ordinance and is not at the request of a resident.

Motion made by Commissioner Ulibarri to approve the road naming resolution. Second by Commissioner Leger. Motion carried.

#### 9. SAN IGNACIO FIRE STATION SITE WORK

SMC Fire Chief Russell Pacheco advised the Commission the San Ignacio Fire Station is in need of road and drainage work.

Motion made by Commissioner Leger to approve to advertise for bids. Second by Commissioner Padilla. Motion carried.

## 10. BID AWARD FOR THE SAPELLO/ROCIADA FIRE STATION IMPROVEMENTS BID RECOMMENDATION

SMC Fire Chief Russell Pacheco advised the Commission San Miguel County received five bids on January 29, 2016 for the Sapello/Rociada Fire Station Improvements.

Motion made by Commissioner Leger to approve bid to Northeastern Construction. Second by Commissioner Ulibarri. Motion carried.

#### 11. RESOLUTION NO. 02-09-16-RA02-ADOPTION OF 2016 COUNTY ROAD LOG FOR AND AUTHORIZATION OF SUBMISSION TO NEW MEXICO DEPARTMENT OF TRANSPORTATION

County Manager Les Montoya advised the Commission the road log is presented by the Public Service Operations Division and for the past 8 years the County has been trying to update the road log and John Tiernan was the only employee willing to take on the task with assistance. The road log is now up to date task and better than what it was.

SMC IT Supervisor John Tiernan advised the County the New Mexico Department of Transportation (NMDOT) requires an on an annual basis, that San Miguel County adopt and submit the, "San Miguel County Road Log." This process certifies San Miguel County for the purpose of qualifying for road funds through the Local Government Road Fund Program as well as other funds that might be available through NMDOT.

Motion made by Commissioner Leger to adopt Resolution No. 02-06-16-RA02 and authorize submission to NMDOT. Second by Commissioner Padilla. Motion carried.

#### 12. APPROVAL OF ELECTRICAL SERVICE AGREEMENT WITH EGB ELECTRIC

SMC Planning and Zoning Division Supervisor Alex Tafoya advised San Miguel County issued a request for proposals for electrical services as-needed for various county buildings. EGB Electric was one of two companies that submitted a proposal.

Motion made by Commissioner Ulibarri to approve agreement. Second by Commissioner Ortiz. Motion carried.

## 13. AUTHORIZATION TO ENTER INTO ELECTRICAL SERVICE CONTRACT WITH SUN RIDGE ELECTRIC

SMC Planning and Zoning Alex Tafoya advised the Commission San Miguel County issued a request for proposals for electrical services for various County buildings as-needed. Sun Ridge Electric and Construction was one of the two electric companies that submitted a proposal.

Motion made by Commissioner Leger to enter into a contract. Second by Commissioner Ortiz. Motion carried.

## 14. RATIFY APPROVAL OF COVER SHEET FOR FY17 LDWI GRANT AND DISTRIBUTION APPLICATION

SMC DWI Coordinator Yolanda B. Cruz advised the Commission the local DWI Grant Fund is established to support programs, services, or activities to prevent or reduce the incidence of DWI. Two sources of program funding are available: distribution and grants. The goal of this grant program is to decrease the number of injuries and fatalities in New Mexico caused by alcohol impaired drivers.

### 15. FEASIBILITY STUDY AUTHORIZATION TO ENTER INTO CONTRACT NEGOTIATIONS SWCA ENVIRONMENTAL

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission San Miguel County issued a request for proposals for planning professional services for a feasibility study to analyze the sources of raw material in sufficient quantities to support a wood pellet facility. Two (2) professional planning companies submitted proposals; SWCA Environmental and Gordon Environmental scored 351 points and Gordon Environmental scored 289 points.

Motion made by Commissioner Leger to authorize entering into a contract with SWCD Environmental. Second by Commissioner Ortiz. Motion carried.
