Motion made by Commissioner Padilla to approve the Resolution. Second by Commissioner Ulibarri. Motion carried.

### 3. NAMING OF SAN MIGUEL COUNTY 12 BED REINTEGRATION CENTER FACILITY THE STEVE B. FLORES REINTEGRATION CENTER FACILITY

Vice-Chair Rock Ulibarri advised the Commission of this written recommendation to name the Reintegration center in honor of Mr. Steve B. Flores and family.

County Attorney Marc Grano opens public hearing at this time. The time will show 3:40 p.m.

### 4. FAIR HOUSING PROCLAMATION RECOGNIZING APRIL AS FAIR HOUSING MONTH

SMC Planning and Zoning Alex Tafoya advised the Commission San Miguel County has received Community Development Block Grant funds. A requirement of receiving such funds is to recognize fair housing as a right guaranteed to all Americans.

Motion made by Commissioner Padilla to approve to adopt proclamation designating April as Fair Housing Month. Second by Commissioner Ortiz. Motion carried.

### 5. RENEWAL OF AGREEMENT WITH JCG PLUMBING

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission San Miguel County has an agreement with JCG Plumbing for plumbing services. The term of the agreement is four (4) years, renewable on an annual basis. JCG Plumbing has indicated that they wish to renew the agreement for a second year beginning May 1, 2016.

Motion made by Commissioner Padilla to renew the agreement. Second by Commissioner Ortiz. Motion carried.

### 6. RENEWAL OF AGREEMENT WITH JEFFREY'S PLUMBING AND HEATING

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission San Miguel County has an agreement with Jeffrey's Plumbing and Heating for plumbing services. The term of the agreement is four (4) years, renewable on an annual basis. Jeffrey's Plumbing and Heating has indicated that they wish to renew the agreement for a second year beginning May 1, 2016.

## 7. AMENDED AGREEMENT FOR INDEPENDENT CONTRACTUAL SERVICES WITH PAUL MAES-SAN MIGUEL COUNTY CLERK'S OFFICE

SMC Clerk Geraldine E. Gutierrez advised the County Clerk's Office has had an agreement with Paul Maes to provide services as outlined in the attached agreement. The agreement is amended and requires approval.

Motion made by Commissioner Padilla to approve the amended agreement as submitted. Second by Commissioner Ortiz. Motion carried.

### 8. AGREEMENT WITH GL ENVIRONMENT FOR OIL AND GAS MANAGEMENT ENGINEERING SERVICES

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission at the February 9, 2016 County Commission meeting, direction was given to County staff by the Board of County Commissioners to enter into contract negotiations with GL Environmental for oil and gas management services. An agreement between San Miguel County and GL Environmental has been prepared and is being submitted for review, consideration and approval.

Motion made by Commissioner Padilla to approve the agreement. Second by Commissioner Ortiz. Motion carried.

## 9. PNM POWER UP GRANT APPLICATION-OUTDOOR SEATING AND GATHERING AREA

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission the County learned of available grant funding through the PNM Power Up Grant program for projects that support community and neighborhood revitalization, area improvements and create meaningful public places such as a park, play area revitalization, outdoor area for public events and landscaping projects. County staff met with the County Manager and determined that an outdoor seating and gathering area within the landscaped portion of the County Administrative Complex would be a project for which to submit an application. County staff prepared and submitted an application for the amount of \$18,380.00.

Motion made by Commissioner Ortiz to ratify the action taken by County staff in preparing and submitting an application to the PNM Power Up Grant Program. Second by Commissioner Ulibarri. Motion carried.

## 10. PRELIMINARY ENGINEERING REPORT MECHANICAL BIOLOGICAL TREATMENT FACILITY

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission Souder Miller and Associates has completed its revisions to the Preliminary Engineering Report (PER) for the Northeastern New Mexico Regional Mechanical Biological Treatment Facility. In order to inform the Board of County Commissioners of the revisions and contents of the PER, Souder Miller and Associates has been asked to bring the Board of County Commissioner and interested public up to date on the final PER.

Souder Miller and Associates Project Manager Ramon Lucero summarized planning the Mechanical Biological Treatment Operation. Mr. Lucero advised the PER concluded the facility is not feasible to develop as planned.

Commission Ulibarri advised he did some research and found some of the information provided in the PER was not consistent with what he found and for these reasons does not support the PER findings. Mr. Ulibarri states he does not support the PER as presented.

Motion made by Commissioner Leger to table PER. Second by Commissioner Padilla. Motion carried.

## 11. AUTHORIZATION TO APPLY FOR THE FEDERAL HAZARDOUS MATERIAL EMERGENCY PLANNING GRANT (HMEP)FROM HOMELAND SECURITY AND EMERGENCY MANAGEMENT

SMC Emergency Manager Kurt Parkinson advised the Commission the San Miguel County/City of Las Vegas Office of Emergency Management is requesting permission to apply for a Federal HMEP Grant. This grant will enable us to develop, improve, implement emergency plans, and train public sector hazardous materials (Hazmat Team). DHS sent the application on February 1, 2016 and it is due on April 18, 2016. The grant is an 80%-20% match and we are still compiling the numbers.

Motion made by Commissioner Padilla to approve to apply HMEP. Second by Commissioner Ortiz. Motion carried.

## 12. RATIFICATION OF APPLICATION FOR THE 2016 NEW MEXICO DEPARTMENT OF HOMELAND SECURITY GRANT PROGRAM (SHSGP)

SMC Emergency Manager Kurt Parkinson advised the Commission Office of Emergency Management/City of Las Vegas Emergency Management received the 2016 SHSGP Grant Application that was due on March 31, 2016. The Grant includes \$135,000.00 for a video conference upgrade for San Miguel County and \$128,935.00 for the City of Las Vegas Police Department Emergency Response Team. This grant program funds a range of activities, including planning, organization, equipment, purchase training, exercises, and management and administration across all core capabilities and mission areas.

Motion made by Commissioner Leger to ratify the application for the 2016 SHSGP. Second by Commissioner Ortiz. Motion carried.

#### 13. FIRE FUND APPLICATIONS 2016

SMC Fire Chief Russell Pacheco advised the Commission he is submitting the Fire Fund Application for twelve (12) Volunteer Fire Districts (VFD) and Fire Administration

Motion made by Commissioner Ortiz to submit Fire Fund Application. Second by Commissioner Ulibarri. Motion carried.

### 14. ROAD PETITION NO. CR 16-005-REQUEST FOR A ROAD VIEWING

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission County staff has submitted Road Petition No. CR 16-005 which petition concerns Vista de Vegas Drive. Staff would like to determine whether Vista de Vegas Drive should be placed on the County road log.

County Manager Les Montoya advised the Commission that the road log is being updated and cleaned up by John Tiernan and Toby Medina. The roads that the County has been maintaining historically were not listed on the road logs and are County roads.

Commissioner Leger advised to search historical data to support adoption. Research of any record determining viewing process.

Motion made by Commissioner Padilla to approve road viewing. Second by Commissioner Ortiz, Motion carried.

### 15. 1st RENEWAL AGREEMENT FOR DETENTION OFFICER UNIFORMS

SMC Warden Patrick Snedeker advised the Commission 1<sup>st</sup> renewal agreement for goods and services specific to detention officer uniforms. San Miguel County Commission approval is sought so that Neve's Uniforms as part of a renewal agreement.

Motion made by Commissioner Ortiz to approve 1<sup>st</sup> renewal agreement. Second by Commissioner Leger. Motion carried.

## 16. RESOLUTION NO. 04-12-16-RA01; ADDITION OF IRISH LN., A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

SMC IT Supervisor John Tiernan advised the Commission a taxpayer has submitted a road name petition to name a private driveway located off of NM Highway 104 between MM14 and MM15. While there is only a single addressed building on this road, San Miguel County Ordinance No. SMC-07-13-99-OED-2 states, "Any private road that provides access to less than three buildings may be names for a fee according to section 4.3". The San Miguel County Rural Addressing staff

has confirmed that the payment was made, and that the proposed road name is in compliance with San Miguel County Ordinance No. SMC-07-13-99-OED-2.

Motion made by Commissioner Leger to approve Resolution. Second by Commissioner Padilla. Motion carried.

### 17. ROAD PETITION NO. CR 16-003-REQUEST FOR A ROAD VIEWING

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission County staff has submitted Road Petition No. CR 16-003, which concerns the road known as Rodeo Grounds Road. Staff would like to determine whether Rodeo Grounds Road should be placed on the County road log or not.

Motion made by Commissioner Ortiz to approve road viewing. Second by Commissioner Leger. Motion carried.

### 18. ROAD PETITION NO. CR 16-004-REQUEST FOR A ROAD VIEWING

SMC Planning and Zoning Division Supervisor advised the Commission County staff has submitted Road Petition No. CR 16-004 which petition concerns Ronnie's Road and Rogers Road. Staff would like to determine whether Ronnie's Road and Roger's Road should be placed on the County road log or not.

Motion made by Commissioner Ulibarri to approve road viewing. Second by Commissioner Ortiz. Motion carried.

## 19. RESOLUTION NO. 04-12-16-RA04; ADDITION OF LEDGE RD., A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

SMC IT Supervisor John Tiernan advised the Commission during a recent address data audit, it was discovered that 10 structures located on a private driveway off of NM Highway 63, North of Pecos NM, between MM9 and 10 had been improperly addressed. San Miguel County Ordinance No. SMC-07-13-99-OED-2 requires, "any private road that provides access to three or more buildings and requires a name in order to promote the health, safety and welfare of the public." The residents were notified of the issue and given the opportunity to request a road name. There was no road naming petition received from the residence, so San Miguel County Rural Addressing staff is proceeding with the suggested road name of Ledge Rd. Due to the road naming being required by Ordinance and not being requested by a resident, the normal fee of \$100 is being waived.

### 20. RESOLUTION NO. 04-12-2016-SMC HEALTH CARE STUDY GROUP

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission that interested and concerned residents of San Miguel County would like to propose that the Board of County Commissioners establish a Health Care Study Group to examine the effects of the Affordable Health Care Act and other changing conditions that affect local health care.

Commissioner Leger advised the plan is to bring all entities and the community to assist in getting involved and find solutions for the Alta Vista Regional Hospital.

Motion made by Commissioner Ulibarri to approve Resolution No. 04-12-2016-HEALTH CARE STUDY GROUP. Second by Commissioner Ortiz. Motion carried.

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission San Miguel County is preparing to issue an invitation for Sealed Proposals for Design and possible construction of an Exterior Seating and Gathering area at the San Miguel County Administrative Complex.

## 22. RESOLUTION NO. 04-12-16-RA03; ADDITION OF H AND R RANCH RD., A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

SMC IT Supervisor John Tiernan advised the Commission during a recent address data audit, it was discovered that four structures located on a private driveway off of CR C53A had been inproperly addressed. San Miguel County Ordinance No. SMC-07-13-99-OED-2 requires, "Any private road that provides access to three or more buildings and requires a name in order to promote the health, safety and welfare of the public." The residents were notified of the issue and given the opportunity to request a road name. The response received via road naming petition was H and R Ranch Rd. due to the road naming being required by Ordinance and not being requested by a resident, the normal fee of \$100 is being waived.

### 23. RECOMMENDATION TO REJECT THE BID-SAN MIGUEL COUNTY DETENTION CENTER

SMC Warden Patrick Snedeker advised the Commission an invitation for bid(s) document was prepared, specific to the San Miguel County Detention Center; for the purchase and installation of security cameras at the San Miguel County Detention Center. \$60,000.00 has been received as a Capital Appropriation for purchase and installation of the security cameras. A bid advertisement was published on March 9, 2016. One bid was received and evaluated on March 29, 2016 at 2:00 pm. The bid received exceeded the funds available for the project. Recommendation is to reject the bid and to re-advertise the project, for completion within funds allowed.

Motion made by Commissioner Padilla to reject bid and re-advertise. Second by Commissioner Ulibarri. Motion carried.

### 24. ROAD PETITION NO. CR16-002-REQUEST FOR A ROAD VIEWING

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission County staff has submitted Road Petition No. CR 16-002 which petition concerns Kemm Drive. Staff would like to determine whether Kemm Drive should be placed on the County road log or not.

Motion made by Commissioner Padilla to approve Petition No. CR16-002. Second by Commissioner Ulibarri. Motion carried.

### 25. ROAD PETITION NO. CR 16-001-REQUEST FOR A ROAD VIEWING

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission County staff has submitted Road Petition No. CR 16-001 which petition concerns County roads A-11-C and A-11-D both enter the city limits of Las Vegas. Staff would like to revise the road log description of these two (2) County roads to ensure maintenance begins at the City limits and County boundary.

Motion made by Commissioner Ortiz to approve Petition No. CR 16-001. Second by Commissioner Leger. Motion carried.

## 26. RATIFICATION AND ACCEPTANCE OF GRANT FUNDING-BEHAVIORAL HEALTH FOR PRISONERS INTERGOVERNMENTAL AGREEMENT(IGA)-\$26,000.00

SMC Warden Patrick Snedeker advised the Commission San Miguel County applied for and has been selected to receive a Department of Finance and Administration, Local Government Division of Finance Intergovernmental Agreement (IGA) in the amount of \$26,000.00 for the provision of behavioral health services for prisoners at the San Miguel County Detention Center. Ratification and acceptance of the IGA funding is requested.

Motion made by Commissioner Ulibarri to ratify and accept the IGA funding amount. Second by Commissioner Ortiz. Motion carried.

## 27. RESOLUTION NO. 04-12-16-RA02; ADDITION OF COYOTE CALL RD., A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

SMC IT Supervisor John Tiernan advised the Commission during a recent address data audit, it was discovered that several structures off of Bibb Industrial Drive had been improperly addressed. Unfortunately, due to the number of structures in the area, the only way to resolve this issue was to require a private driveway be named. The residents were notified of the issue and given the opportunity to request a road name. The only response received from a resident was Coyote Call Rd. Due to the road naming being required by Ordinance and not being requested by a resident, the normal fee of \$100 is being waived.

received by Wagner Equipment and 4 Rivers Equipment. Bids were open on February 10, 2016 and 4 Rivers Equipment was the lowest most qualified bidder for the monthly lease payment of \$2,492.46.

Three bids received by Wagner Equipment, Bobcat of Albuquerque and 4 Rivers Equipment. Bids were open on February 10, 206 and 4 Rivers Equipment was the lowest most qualified bidder for the monthly lease payment of \$2,643.19.
