## MINUTES OF REGULAR MONTHLY MEETING OF SAN MIGUEL COUNTY BOARD OF COMMISSIONERS HELD TUESDAY, JUNE 14, 2016 BEGINNING AT 2:00 P.M.

### **CALL TO ORDER**

The San Miguel County Board of Commissioners held its regular monthly meeting on Tuesday, June 14, 2016, beginning at 2:00 p.m. The meeting convened at the County Commission Chambers, San Miguel County Courthouse, 2<sup>nd</sup> floor, 500 West National Ave., Suite 200, Las Vegas, New Mexico 87701.

### **ROLL CALL:**

Upon a call of the roll, Chairman Gilbert J.B. Sena, Vice-Chairman Rock Ulibarri, and Commissioners Arthur J. Padilla, Marcellino A. Ortiz, and Nicolas T. Leger were present, and a quorum was duly noted.

### PLEDGE OF ALLEGIANCE AND SALUTATION TO NM STATE FLAG

Commissioners, staff and citizens in attendance joined in the pledge and salute.

### APPROVAL OF AGENDA

County Manager Les Montoya requested that Item No. 25 (New Mexico Detention Center(s) – Training Academy Program) be removed from the agenda for additional time to work out specifics for the contract.

Commissioner Rock Ulibarri requested to add San Rafael project to the agenda. County Manager Les Montoya informed the Commission this Project would be discussed in executive session due to the fact that it was related to a personnel matter.

Dr. Dennis Aragon presented an event summary which he claimed provided over a million dollars of dental treatment to 1,218 patients in the New Mexico Mission of Mercy Event. ### **REGULAR ORDER**

1. RESOLUTION NO. 06-14-16-CM-LOAN AGREEMENT AND INTERCEPT AGREEMENT BY AND BETWEEN SAN MIGUEL COUNTY AND THE NEW MEXICO FINANCE AUTHORITY

County Manager Les Montoya informed the Commission that the New Mexico Finance Authority approved a loan application for the amount of 3.8 million dollars to complete various road and drainage improvements throughout San Miguel County. Mr. Montoya submitted Resolution No. 06-14-16-CM-Loan Agreement and Intercept Agreement by and between San Miguel County and the New Mexico Finance Authority for approval and place the Loan Ordinance on the July 2016 Commission agenda in order to secure the loan for San Miguel County.

Motion made by Commissioner Padilla to approve Resolution No. 06-14-16-CM-Loan and place the Loan Ordinance on the July 2016 Commission agenda, Second by Commissioner Ulibarri. Motion carried.

2. CONTRACT WITH RBC CAPITAL MARKETS TO PERFORM AS FINANCIAL ADVISOR FOR SAN MIGUEL COUNTY ON AN AS NEEDED BASIS.

County Manager Les Montoya made a recommendation to contract with RBC Capital Markets to perform as financial advisor for San Miguel County on an as needed basis. Mr. Montoya said the contract has been reviewed by the County Attorney.

Motion made by Commissioner Padilla to approve to contract with RBC Capital Markets to perform as financial advisor for San Miguel County on an as needed basis, Second by Commissioner Ortiz. Motion carried.

Mr. Paul Cassidy, financial advisor with RBC Capital Markets gave a small presentation.

### 3. RESOLUTION NO. 06-14-2016-CM-A RESOLUTION SUPPORTING CONSERVATION OF OIL AND GAS A NATURAL RESOURCE DEVELOPMENT

Commissioner Ulibarri gave some background information regarding the venting and flaring and leaking of methane gas in BLM land. Commissioner Ulibarri informed the Commission that President Obama and Senator Udall have been working on the capping rule to stop venting and flaring and leaking of methane gas in the BLM land. Commissioner Ulibarri read the Resolution and made an amendment adding to the 10<sup>th</sup> paragraph greenhouse gases the causes of climate change. Discussion ensued. Commissioner Ulibarri presented Resolution No. 06-14-2016-CM-A Resolution supporting Conservation of Oil and Gas, Natural Resource Development for approval with the amendment.

Motion made by Commissioner Padilla to approve Resolution No. 06-14-2016-CM-A-Resolution supporting Conservation of Oil and Gas a Natural Resource Development as amended, Second by Commissioner Ortiz. Motion carried.

### 4. RESOLUTION NO. 06-14-2016-LEDA FUND BALANCE OF \$19,305.82

SMC Planning and Zoning Supervisor, Alex Tafoya informed the Commission that there is a balance of LEDA Funds that were provided for the Martinez & Sons Processing project that are available for economic development purposes the balance is \$19,305.82. San Miguel County is attempting to coordinate efforts with the New Mexico Economic Development Department to keep such funds available within San Miguel County for econonimic development uses. One of the steps in making such funds available for other uses, is to terminate the various agreements regarding the Martinez & Sons Processing Project. Mr. Tafoya requested that the Commission consider and approve Resolution No. 06-14-2016-LEDA Fund Balance of \$19,305.82 which will authorize passage of an Ordinance terminating the various agreements regarding the Martinez & Sons Processing Project and making such LEDA funds available.

Motion made by Commissioner Leger to approve Resolution No. 06-14-2016-LEDA Fund Balance of \$19,305.82 which will authorize publications of an Ordinance proposing terminating the various agreements regarding the Martinez & Sons Processing Project and making such LEDA funds available, Second by Commissioner Padilla. Motion carried.

Chairman Sena requested that they go back to the presentation that will be presented by Dr. Dennis Aragon.

### 5. SHERIFF'S OFFICE RELOCATION AND EXPANSION PROPOSAL

SMC Sheriff Gary Gold addressed the Commission regarding the Sheriff's Office space and parking limitations. Mr. Gold said that he is doing the best to utilize the space at the jail but the sheriff's office is growing and so is the jail. Mr. Gold went over the different possibilities and options for the sheriff's office space in order to save the county money. Mr. Gold went over a proposal for the remodeling of the building located at 1124 Railroad which Phase I would cost \$86,541.00. Mr. Gold went over the different phases that would take to complete the sheriff's office located at 1224 Railroad. Mr. Gold stated that coming in as sheriff he has encountered

many obstacles. Mr. Gold stated how they handle these obstacles will determine how we can provide good public service to residents of San Miguel County. Chairman Sena asked for the anticipated date of completion for this project. Mr. Montoya said the project should be completed late summer of next year depending on a lot of things. Mr. Montoya said that all this is conceptional at this time the first issue to address is whether or not we want to dedicate this space for future emergency and first responders. The second issue is identifying a funding. We are presently considering a possible refinance of existing debt to create funding for this project. In addition, Mr. Montoya mentioned the possible passage of a gross receipts tax for further development of this property as a central dispatch facility for all area first responders. The Commission gave Mr. Montoya authorization to proceed with the project to develop the property. No Motion was made.

## 6. REQUEST FOR INFORMATIONAL PROPOSALS TO BE SOLICITED BY THE SAN MIGUEL COUNTY LODGERS TAX ADVISORY BOARD (LTAB ON THE USE OF LODGERS'S TAX REVENUES IN FISCAL YEAR 2016-17.

County Manager Les Montoya informed the Commission that he had met with the Lodgers' Tax advisory Board on June 8, 2016 provided information of the projected revenues and expenditures ending June 30, 2016 and the proposed revenues in the budget for 2016-17. He advised approximately \$25,000.00 of Lodger's Tax would be available to appropriate in 2016-17. The Lodger's Tax advisory board recommended obtaining request for information proposals from entities having to use Lodger's Tax Dollars in 2016-17.

Motion made by Commissioner Leger to approve the request for information and the solicitation of proposals for Marketing, Advertisement and Promotion of San Miguel County, Second by Commissioner Ortiz. Motion carried.

### 7. APPOINTMENT TO PLANNING AND ZONING COMMISSION DISTRICT 5

SMC Planning and Zoning Supervisor Alex Tafoya advised the Commission that a Planning and Zoning Commission member representing County Commission District 5 moved from Las Vegas and a vacancy exists on the Planning and Zoning Commission. Mr. Tafoya requested the Commissioner from District 5 to consider filling the vacancy. Commissioner Leger informed the Commission he would nominate a person at the next meeting to fill the vacancy.

No motion was made.

### 8. REQUEST FOR PUBLIC HEARING REGARDING FIREWORK USAGE IN SAN MIGUEL COUNTY

SMC Emergency Manager Kurt Parkinson informed the Commission he had received a letter from Susana Martinez, Governor, where she advises municipalities and Counties to hold a public hearing to discuss the banning of fireworks. After much discussion if a public hearing could be held regarding the banning of fireworks, Mr. Marc Grano informed the Commission that all requirements had been complied regarding open meeting act; therefore public comment could be heard. Chairman Sena asked if any person had any comments in favor of banning of fireworks.

The persons that came forward in favor of banning fireworks were as follows:

Yolanda Cruz informed the Commission that she resides in Manuelitas and she is in favor of banning fireworks.

SMC Sheriff Gary Gold came forward and informed the Commission that he stands for public safety but does not want to take fireworks from the children. Mr. Gold suggested the Commission hold a special meeting informing the public regarding the banning of fireworks. Mr. Gold informed the Commission that he is not neither for nor against banning fireworks.

Chairman Sena invited any public comment regarding not banning fireworks.

Arnold Lopez said that he neither for nor against banning fireworks and agrees with Mr. Gold and it would be wise to hold a special meeting because a lot of vendors depend on selling fireworks.

Chairman Sena informed the Commission that it is not necessary to hold a special meeting regarding the banning of fireworks; notice was given to the public. Mr. Grano agreed with Chairman Sena stated that all open meeting act had been met.

SMC Emergency Manager Kurt Parkinson made a recommendation not to ban fireworks in San Miguel County.

Motion made by Commissioner Padilla to approve recommendation not to ban fireworks, Second by Commissioner Ortiz. Motion carried.

### 9. ADDENDUM TO AGREEMENT – CONCHA MONTANO – PROFESSIONAL SERVICES AGREEMENT # SMC DWI 11-18-14

SMC DWI Coordinator Yolanda Cruz presented for approval the Addendum to Agreement # SMC DWI 11-18-14 between San Miguel County DWI Program and Conchas Montano for evaluation services for FY 2014-2015. The Agreement will be at a reduced monthly and yearly amount due to the scope of work being reduced from evaluation of two components to one.

Motion made by Commissioner Padilla to approve Addendum to Agreement# SMC DWI 11-18-14 as presented, Second by Commissioner Ortiz. Motion carried.

### 10. PROJECT PARTICIPATION LEASE AGREEMENT BETWEEN COUNTY AND OLD WOOD LLC

SMC Planning and Zoning Division Supervisor Alex Tafoya informed the Commission this item is for informational purposes only. Mr. Tafoya informed the County received USDA funds to purchase a truck and trailer for economic development purposes for a small and emerging business. The initial lessee defaulted on the lease agreement for the truck and trailer therefore making the equipment available for use. The USDA was contacted and the USDA would like for the truck and trailer to remain in San Miguel County for a small and emerging business. Mr.

Tafoya stated that a letter of interest was advertised and Old Wood LLC expressed interest in leasing the truck and trailer. Mr. Tafoya informed that Old Wood LLC certified to the County that they were a small and emerging business and stated other wise to the USDA. USDA made some changes to the lease agreement regarding insurance and maintenance costs. These costs were allowed as the lease payment to USDA, they have asked that these costs be removed and not be a part of the lease payment. Mr. Tafoya requested that the Commission review the participation lease agreement and informed them that Old Wood LLC needs to be approved by the County as a local economic project.

Commission authorizes the County Manager Les Montoya and Mr. Alex Tafoya to move forward with this project.

### 11. RESOLUTION PROPOSING ADOPTION OF AN ORDINANCE APPROVING OLD WOOD LLC AS A LOCAL ECONOMIC DEVELOPMENT PROJECT.

SMC Planning and Zoning Division Supervisor Alex Tafoya presented Resolution No. 06-14-16-LED which will authorize the County Manager to do what is necessary and proper for the final passage and adoption of an ordinance approving Old Wood LLC as a local economic development project in compliance with the County's economic being County Ordinance No. 07-09-13-LEDA. Mr. Tafoya requested to consider and approve Resolution No. 06-14-16-LED which proposes adoption of an ordinance approving Old Wood LLC as a local economic development project, whereby the County would then be able to enter into a project participation lease agreement.

Motion made by Commissioner Leger to approve to Resolution No. 06-14-16-LED, Second by Commissioner Ortiz. Motion carried.

### 12. RECOMMENDATION TO AWARD BID FOR WHEEL LOADER BID

SMC Public Service Operations Division Supervisor Robert Archuleta advised the Commission that the San Miguel County Public Service Department went out for advertisement and opened bids on May 31, 2016. Mr. Archuleta recommended that the bid be awarded to Wagner Equipment for they were the lowest bidder. SMC Public Service Operations Division Supervisor Robert Archuleta advised the Commission that the San Miguel County Public Service Department went out for advertisement and opened bids on May 31, 2016.

Motion made by Commissioner Ortiz to award bid to Wagner Equipment, Second by Commissioner Ulibarri. Motion carried.

#### 13. RECOMMENDATION TO AWARD BID FOR MOTOR GRADER LEASE

SMC Public Service Operations Division Supervisor Robert Archuleta advised the Commission that the San Miguel County Public Service Department went out for advertisement and opened bids on May 31, 2016 for a Motor Grader Lease. Mr. Archuleta advised the Commission the cost of the lease would be \$ 2069.00 per month for a three-year lease. Mr. Archuleta

recommended the bid to lease the motor grader lease be awarded to Wagner Equipment for they were the lowest bidder on leasing two motor graders.

Motion made by Commissioner Ulibarri to award bid to Wagner Equipment, Second by Commissioner Leger. Motion carried.

### 14. ADDENDUM TO AGREEMENT – MILLER ENGINEERING CONSULTANTS, INC.

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission that the professional services engineering agreement between San Miguel County and Miller Engineering Consultants provides for engineering services as needed and is due for renewal. Miller Engineering has indicated that they wish to renew the agreement for a fourth year. Mr. Tafoya recommended the Commission approve the addendum to agreement extending the professional engineering services agreement between San Miguel County and Miller Engineering for a fourth year.

Motion made by Commissioner Leger to approve addendum to agreement extending the professional engineering services agreement between San Miguel County and Miller Engineering Consultants, Inc. for a fourth year Second by Commissioner Ortiz. Motion carried.

#### 15. ADDENDUM TO AGREEMENT – ENGINEERS INC.

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission San Miguel County has a professional services agreement with Engineers Inc., for engineering services as needed. The agreement provides for renewal on an annual basis. Engineers Inc. has advised that they wish to renew the agreement for a fourth year.

Motion made by Commissioner Ulibarri to approve the addendum to the agreement with Engineers Inc. Second by Commissioner Padilla. Motion carried.

#### 16. FY17 DWI GRANT AGREEMENT # 16-D-J-G-26

SMC DWI Coordinator Yolanda B. Cruz advised the Commission that the San Miguel County received a DWI Grant award for FY 17 from NM Department of Finance and Administration – Agreement # 17-D-J-G-26, which provides \$38,000.00 to assist with the DWI planning Council prevention activities.

Motion made by Commissioner Ulibarri to accept the FY 17 Grant Agreement # 17-D-J-G-26 as presented, Second by Commissioner Ortiz. Motion carried.

### 17. RATIFICATION OF 2<sup>ND</sup> AMENDMENT TO FY16 DWI GRANT AGREEMENT # 16-D-J-26

SMC DWI Coordinator Yolanda B. Cruz advised the Commission that the San Miguel County to fully utilize the funds awarded under FY 16 DWI Grant Agreement # 16-D-J-G-26 an amendment that moves money between line items is required. Ms. Cruz requested approval to ratify the 2<sup>nd</sup> Amendment to FY 16 DWI Grant Agreement # 16-D-J-G-26.

Motion made by Commissioner Ulibarri to approve to ratify the 2<sup>nd</sup> Amendment to FY 16 DWI Grant Agreement, Second by Commissioner Ortiz. Motion carried.

### 18. EXTERIOR SEATING AND GATHERING AREA AUTHORIZATION TO NEGOTIATE CONTRACT

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission of San Miguel County issue a request to submit sealed proposals for design and possible construction of an exterior seating and gathering area of the front side of the County Complex building. The county received one (1) proposal and county staff would like to enter into project discussion and possible contract negotiations with Sites Southwest. Mr. Tafoya requested authorization to begin project discussion and contract negotiations with Sites Southwest.

Motion made by Commissioner Ortiz to approve authorization to begin project, discussion and contract negotiations with Sites Southwest, Second by Commissioner Ulibarri. Motion carried.

### 19. RESOLUTION NO. SMC-RES-SO-06-14-2016-SHERIFF'S OFFICE-EXCESS PROPERTY

SMC Sheriff Gary Gold informed the Commission that the Sheriff's office has six (6) vehicles that need to be declared excess property. Mr. Gold requested that the Commission approve Resolution No SMC-RES-SO-06-14-2016- Sheriff's Office –Excess Property declaring vehicles excess property to be cleared for auction.

Motion made by Commissioner Padilla to approve Resolution No SMC-RES-SO-06-14-2016-Sheriff's Office –Excess Property declaring vehicles excess property to be cleared for auction, Second by Commissioner Ulibarri. Motion carried.

### 20. RECOMMENDATION FOR AWARD OF BID FOR THE INSTALLATION OF SECURITY CAMERAS AT THE SAN MIGUEL COUNTY DETENTION CENTER.

SMC Warden Patrick W. Snedeker advised the Commission San Miguel County, NM solicited competitive sealed bid(s), from a qualified vendor(s), for the installation of security cameras at the San Miguel County Detention Center. Mr Snedeker requested the Commission to review and consider granting approval to award bid to the Electric Horseman, the lowest most qualified bidder.

Motion made by Commissioner Padilla to award bid to the Electric Horseman the lowest most qualified bidder, Second by Commissioner Ulibarri. Motion carried.

### 21. PUBLIC SERVICE DIVISION REPORT FOR THE MONTH OF MAY 2016.

SMC Public Service Operation Division Road Foreman Arnold Lopez presented the Commission monthly report for May regarding any maintenance done including blading of county roads and /or special projects with County Roads that are addressed.

# 22. RESOLUTION NO. 16-14-16-DWI – INTENT TO ADVERTISE TO ADOPT COMPLIANCE FEES ORDINANCE SETTING A \$15-\$50 MONTHLY COMPLIANCE FEE FOR DWI CLIENTS ON NEW AND RENEWED PROBATION CLIENTS WITH THE SAN MIGUEL COUNTY DWI PROGRAM.

SMC DWI Coordinator Yolanda B. Cruz advised the Commission that the County DWI Compliance Components/DWI Programs across NM are hearing strong recommendations by the NM DWI Grant Council to collect all fees allowed under Section 31-20-5.1(A) NMSA 1978. The San Miguel County DWI Program is planning to come into alignment with this recommendation in the upcoming fiscal year. Compliance fees collected will be utilized to assist with costs associated to this component, as required by the statutes. Ms Cruz recommended the Commission to review the proposed resolution and approve resolution and direct County Staff to proceed advertising Ordinance with intent to adopt said ordinance with intent to adopt said ordinance at the July 2016 Commission meeting.

SMC Warden Patrick W. Snedeker advised the Commission that a listing has been compiled of detention center outstanding balances that are specific to the housing/care of other public agency detainees; that are uncollectable. The enumerated public agency locations are unidentifiable within terms of collecting payment (s) submitted and/or have cited NMSA –33-3-14 confinement in a county other than in which the crime was committed; expense borne by county; as valid justification for no-payment. Approval to expunge the outstanding balances, as enumerated as uncollectable is being sought.

Motion made by Commissioner Padilla to approve to expunge the outstanding balances, as enumerated as uncollectable as presented, Second by Commissioner Ulibarri. Motion carried.

## 24. ACCEPTANCE OF FUNDS FOR THE "MORADA DE SANTANA" TIRE REMOVAL GRANT APPLICATION NEW MEXICO ENVIRONMENT DEPARTMENT

SMC Public Service Operations Division Supervisor Robert Archuleta advised the Commission that the San Miguel County Public Service Department recently submitted a grant application request to the New Mexico Environment Department for the removal of a large volume of tires from the Morada de Santana located west of the Shooting Range of Gunner Road which is a county road. The SMC Public Service Division collaborated with the group and prepared and submitted the grant application. Thirty six (36) applications for the RAID Grant were submitted and San Miguel County was ranked the highest # 1 application and was awarded funds. San Miguel County was awarded the grant in the amount of \$10,200.00. Mr. Archuleta requested the Commission accept the funds from the NM Environment Department and implement the grant.

### 26. ADMINISTRATIVE REGULATION NO. ADM-CM-06-14-16 – PROHIBITING THE SALE OF ALCOHOL ON COUNTY PROPERTY

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission that at the May 10, 2016 County Commission meeting, the Board of County Commissioners decided against allowing the sale of alcohol on the property of the San Miguel County Fairgrounds. An administrative regulation prohibiting both the sale and consumption of alcohol on the property of the fairgrounds has been prepared.
