Tri-County Family Justice Center member Ashley Archuleta presented the annual report of services provided by the Tri-County Family Justice Center. The center provided services to 301 survivors including witnesses of domestic abuse.

SMC Human Resource Division Supervisor Kiki Arellano presented a Risk Awareness Program Award plaque presented by the New Mexico Association of Counties to San Miguel County, recognizing San Miguel County for its reduction in Workers' Comp claims and multi-line claims.

Commissioner Leger updated those in attendance regarding issues that may or may not impact Counties in the State of New Mexico like House Bill 233-remove hold harmless GRT resources presently available to the County, including efforts to removing posting of bond for dangerous criminals. House Bill 211-preempt to regulate minimum wage and time off benefits. Mr. Leger also stated efforts to consolidate school board, municipal, etc., elections to save money.

## 1. TRANE AGREEMENT RENEWAL

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission San Miguel County has a service agreement with TRANE Building Services for maintenance of the heating and cooling systems in various County buildings. SMC IT Supervisor John Tiernan advised the Commission during a routine audit of San Miguel County addressing data, it was discovered that there was an addressing error on Bibb Industrial Dr. There were three houses that were given odd addresses, even though they were on the even numbered side of the street. Because of the other addressed structures in the area, the only way to resolve this issue is to classify the current driveway as a named private drive and readdress the houses on this newly named private road. Per San Miguel County Ordinance No.SMC-07-13-99-ORD-2, Section 4.1-C, to San Miguel Board of County Commissioners will review and take appropriate action on road naming for, "any private road that provides access to three or more buildings and requires a name in order to promote the health, safety and welfare of the public."

The San Miguel County Rural Addressing office is waiving the normal fee due to the fact that these houses were addressed in error.

SMC Planning and Zoning Division Supervisor Alex Tafoya advised the Commission San Miguel County presently has three (3) individuals who serve as County road viewers. Due to scheduling conflicts arise from time to time, there have been occasions when a road viewer is unable to attend a road viewing, thus leaving only two (2) road viewers to participate. County staff has determined that it might be helpful to have a fourth person to serve as an alternate road viewer. Daniel Encinias, a retired County Public Works Foreman, has expressed an interest in serving as a road viewer.

Two sources of program funding are available: distribution and grants. The goal is this grant program is to decrease the number of injuries and fatalities in New Mexico caused by alcohol impaired drivers. This application will fund the project year July 1, 2016 through June 30, 2017.

# 14. REQUEST TO AWARD SEALED QUOTES OBTAINED AND OPENED ON JANUARY 22, 2016 IN REFERENCE TO THE PURCHASE OF TRAIL MAINTENANCE EQUIPMENT (UTLITY TRACTOR, FLAIL MOWER AND ROTARY CUTTER)

SMC Manager Les W.J. Montoya advised the Commission the County obtained a grant in the amount of up to \$40,000.00 to purchase a tractor and attachments for the purpose of maintaining trails and right of ways. The County attempted on three (3) occasions to purchase equipment through sealed bids. The last advertisement resulted in one response and that response was over the grant amount. Sealed quotes were solicited and five (5) were obtained.

Mr. Montoya advised the quote was in the amount of \$42,176.00 from Ray Lee Equipment. The total grant amount is \$36,035.17 and the County will pay the difference of \$6,140.83 from cash balance funds.

Commissioner advised to replace with CR C-23 and name this project the S turns.

Commissioner Ulibarri expressed his concerns on the deterioration on CR A-27 road.
