CALL TO ORDER

The San Miguel County Board of Commissioners held its regular monthly meeting on Tuesday January 10, 2017, beginning at 2:00 p.m. The meeting convened at the San Miguel Administration Complex located at 500 West National Avenue, Suite 200, New Mexico 87701.

1. ELECTION OF CHAIRMAN AND VICE-CHAIRMAN OF THE SAN MIGUEL COUNTY BOARD OF COMMISSIONERS

San Miguel County Commissioner Rock Ulibarri informed the Commission that according to Section 4-38-10, NMSA 1978, it is required that at the first meeting of each year, County Commission select a Chairman and Vice-Chairman.

Motion made by Commissioner Varela to nominate Commissioner Ulibarri to the seat of Chairman. Second by Commissioner Martinez. Motion carried.

Motion made by Commissioner Ulibarri to nominate Commissioner Padilla to the seat of Vice-Chairman. Second by Commissioner Najar. Motion carried.

2. ADOPTION OF OPEN MEETING ACT RESOLUTION FOR 2017

San Miguel County Attorney Marc Grano informed the Commission that Section 10-15-1 of the New Mexico Open Meetings Act, NMSA 1978, requires that each year the County Commission adopt a Resolution setting forth the date and time of the Commission Meetings and notice requirements for all meetings. Mr. Grano requested the Commission adopt the Open Meetings Resolution for 2017 as required by law.

Motion made by Chairman Ulibarri to approve the adoption of the Open Meeting Act Resolution for 2017. Second by Commissioner Varela. Motion carried.

3. APPOINTMENT TO CITY/COUNTY EXTRA-TERRITORIAL ZONING AUTHORITY

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission of the City/County Extra-Territorial Zoning Authority consists of five (5) members as provided by the Joint Powers Agreement between the City of Las Vegas and San Miguel County that established extra-territorial Zoning, consisting of two members from the city and three from the County. Mr. Bustos requested the Commission appoint another County Commissioner to serve on the Extra-Territorial Zoning Authority to replace former County Commissioner Nicolas Leger.

Motion made by Chairman Ulibarri to appoint Commissioner Najar to replace former County Commissioner Leger's seat to the Extra-Territorial Zoning Authority. Second by Vice-Chairman Padilla. Motion carried.

4. REQUEST FOR COMMISSIONERS TO CONSIDER APPOINTING MEMBERS TO THE SAN MIGUEL COUNTY COMPREHENSIVE PLAN STEERING COMMITTEE

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission that San Miguel County is working on updating the County's comprehensive plan. The County and Consultants will conduct a series of public visionary meetings. The steering committee will work with County staff and planning consultants to conduct 4-5 meetings to help guide the subarea meetings, develop information and policy direction on the topics of the plan elements, and conduct general public meetings on the draft plan before developing a draft plan to present to the Board of County Commissioners. Topics in the plan are land use, housing, transportation, infrastructure, economic development, water hazards mitigation and implementation. The project also plans to complete a Pecos Subarea Plan. Commissioner Martinez suggested the Commission hold back on conducting the 4-5 subarea meetings until the steering committee members were appointed. San Miguel County Attorney Marc Grano informed the Commission that if there is no financial impact on this project it would be fine to postpone this project till next month.

5. APPOINTMENTS TO SAN MIGUEL COUNTY PLANNING AND ZONING COMMISSION

San Miguel County Planning and Zoning Supervisor Ralph Bustos informed the Commission the terms of the San Miguel County Planning and Zoning Commission members who represent Commission District two (Janice Varela), Four (Mr. Richard Flores), and Five (Mr. Robert Gutierrez) have expired. It is necessary to either reappoint one or more members and/or to appoint new members to serve on the Planning and Zoning Commission, to be considered at the February Commission Meeting.

6. APPOINTMENT TO CITY/COUNTY EXTRA-TERRITORIAL ZONING COMMISSION

San Miguel County Planning and Zoning Supervisor Ralph Bustos informed the Commission the current Joint Powers Agreement between the City of Las Vegas and San Miguel County that established extra-territorial zoning provides for an Extra-Territorial Zoning Commission, which consists of five members, two from the Las Vegas City Council, two from San Miguel County, and one member appointed by the majority of the members. The term of Leroy H Garcia, one of the individuals who represent San Miguel County on the Extra-Territorial Zoning Commission has expired. It is necessary to either re-appoint him or to appoint another individual to serve the Commission. The term as per the Joint Powers Agreement is a two year term. Mr. Bustos requested the Commission consider for the February meeting either re-appointing Mr. Garcia as a representative of the County or appoint a new member.

Discussion ensued.

7. APPROVAL OF LIQUOR LICENSE APPLICATION

San Miguel County Planning and Zoning Supervisor Ralph Bustos informed the Commission that Western Refining Retail, LLC DBA Giant #078 has received preliminary approval from NM Regulation and Licensing Department, Alcohol and Gaming Division, for the transfer of ownership of existing NM Dispenser Liquor License No. 0350. The County Commission is now required to provide approval or disapproval of the Liquor License Application. If approved, the transferred license will be located at the Giant station located in Romeroville. Mr. Bustos requested that the Commission conduct a public hearing and accept comments, and (2) take action to approve or deny the Liquor License Application.

San Miguel County Chairman Rock Ulibarri called a public hearing to order at 3:33 PM. First item on the list is the support of the approval for the Liquor License in Romeroville.

Maurice Banal- Representing Agent representing the transfer of the liquor license from the North Dock Marina to the Giant Store in Romeroville. Diane Rodriguez-Operations Manager for Western Refining Operations and the Romeroville Giant stated they are responsible management and they have zero tolerance for sale of Liquor or tobacco. Randy Banrinkly-Facility Sole Director, worked with the Romeroville Giant Store to make sure that they up hold the law. San Miguel County Commissioner Maria Martinez questioned Western Refining how it was put out to the community that they were proposing to sell liquor at the Giant Store in Romeroville. Wayne Chew- Lawyer for the Conchas North Dock Marina addressed the matter of the transfer of the Liquor License to the Giant Store in Romeroville. The Public hearing in favor of the approval of the liquor license concluded at 3:56 PM.

San Miguel County Chairman Rock Ulibarri at 3:57 PM requested that all opposing the Liquor License in Romeroville to please step forward.

Catherine Kahn-very much opposes the approval of the liquor license in Romeroville. San Miguel County DWI Coordinator Yolanda Cruz presented to the Commission data provided by law in regards to the sales of alcohol. According to statistics San Miguel County is fourth in the state for exceeding the sales of liquor and fifth in the state for the most alcohol related deaths. Jim Henning- asked how the sheriff feels about selling liquor in the vicinity of the highway. San Miguel County Sherriff Gary Gold stated he was not for or against the liquor license approval in Romeroville but rather is concerned about the bad choices that people make when they purchase liquor. Ralph Lambach-strongly opposes the liquor license approval in Romeroville. San Miguel

County Attorney Marc Grano informed the Commission that if they feel as if they do not have information in regards to the Liquor License Application and feel that they need more time to review this, then they can do so.

Motion made by Commissioner Najar to table Item #7, Approval of Liquor License until February's Monthly Meeting. Second by Vice-Chairman Padilla. Motion carried.

8. REQUEST TO RATIFY FY2017 CDWI GRANT APPLICATION

San Miguel County DWI Coordinator Yolanda Cruz informed the Commission the San Miguel County DWI Program was notified of a \$6,800 award of CDWI funds. The Community DWI Grant Fund is administrated by the NM Department of Transportation to support very specific activities. The funds will be used to support the Safe Ride Home service. Ms. Cruz requested the Commission ratify the FY17 CDWI Grant Application.

Motion made by Commissioner Najar to Ratify FY2017 CDWI Grant Application. Second by Commissioner Varela, Motion carried.

9. VEHICLE LEASE AGREEMENT BETWEEN SAN MIGUEL AND OLD WOOD LLC

San Miguel County Grants Writer Alex Tafoya informed the Commission the San Miguel County has been advised by the USDA office in Albuquerque that the County can proceed with the vehicle lease agreement between the County and Old Wood LLC, which provides for the lease of one pickup truck and one trailer. County staff proceeded to finalize the agreement with Old Wood LLC. Mr. Montoya requested the Commission ratify the action taken by County staff in finalizing the vehicle lease agreement.

Motion made by Chairman Ulibarri to ratify the action taken by County staff. Second by Commissioner Najar. Motion carried.

10. SAN MIGUEL COUNTY TITLE VI PLAN

San Miguel County Public Service Division Supervisor Morris Madrid informed the Commission that San Miguel County is required to approve a formal Title VI Plan to provide assurance of compliance with federal laws and regulations relating to Non-Discriminatory practices for relevant federally funded programs and projects. Mr. Madrid requested the Commission approval for title VI Plan.

Motion made by Commissioner Varela to approve the San Miguel County Title VI Plan. Second by Vice-Chairman Padilla. Motion carried.

11. REQUEST FOR SPECIAL MEETING OF THE SAN MIGUEL COUNTY BOARD OF COUNTY COMMISSIONERS

San Miguel County Warden Patrick Snedeker informed the Commission the San Miguel County Detention Center is scheduling to accommodate the Board of Commissioners with a walk through/inspection of the County Detention Center. The recommended time and date is 10:00 am on January 24, 2017. This requires the scheduling of a Special Meeting of the San Miguel County Board of Commissioners. Mr. Snedeker requested the Commission consider the invitation and confirm a date to complete the annual inspection of the San Miguel County Detention Center by the Board of Commissioners.

San Miguel County DWI Coordinator Yolanda Cruz informed the Commission that Monica Padilla, DWI Specialist is in the process of achieving her Bachelor Degree in Early Childhood Development. Ms. Cruz is requesting the Commission approval for the costs of classes and applicable books be considered for reimbursement from Imus Funds, once Ms. Padilla successfully passes.

14. RESOLUTION NO. 01-10-2017-ACEQUIAS WHICH SUPPORTS OPPOSITION TO WATER RIGHTS TRANSFERS FROM ACEQUIAS TO RESIDENTIAL OR COMMERCIAL USE.

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission the staff has been advised that an application for a water rights transfer has been submitted to the State Engineer's Office which would divert water from the West Pecos Ditch. It has been suggested that the Board of County Commissioners consider the adoption of a Resolution stating that the transfer of water rights in San Miguel County from traditional uses such as irrigation by the acequias, to residential subdivision or commercial uses, elsewhere in the County or State. Mr. Bustos requested the Commission review and discuss the proposed resolution and take action to either approve or disapprove this resolution.

Motion made by Commissioner Varela to table the Resolution No. 01-10-2017 till next month meeting in February. Second by Commissioner Martinez. Motion carried.

15. REQUEST THAT THE BOARD OF COUNTY COMMISSIONERS DICUSS THE APPROPRIATIONESS OF FILING A PROTEST WITH THE OFFICE OF THE NEW MEXICO STATE ENGINEER REGARDING THE APPLICATION FROM STRICKLING RANCH PARTNERS, LP AND THE HERMAN GALLEGOS REVOCABLE TRUST FOR A PERMIT TO CHANGE POINT OF DIVERSION AND CHANGE OF PLACE OF USE OF SURFACE WATERS OF THE PECOS RIVER

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission the point of diversion of the West Pecos Ditch was clarified in the amended application with the Office of the New Mexico State Engineer which proposes to cease the diversion of 19.99 acre-feet per annum, Consumptive use of 10.00 acre feet, of surface water from the Pecos River by a movable river pump from within 500 foot radius of eight separate locations. Any objection to the approval of the application must be based on (1) impairment; if impairment, objector must specifically identify their water rights; and or (2) Public Welfare/Conservation of

Water; if public welfare or conservation of water within the State of New Mexico, objector must show how the objector will be substantially and specifically affected.

San Miguel County Chairman Rock Ulibarri asked the public at this time if anyone would like to step and speak in regards to the acequia issues.

Ralph Vigil-Chairman of NM Acequia Commissioners Association eleven group member appointed by the Governor requesting the County Commissioners support this protest.

Andres Aragon-Protesting the water transfer strongly urges County Commission to consider protesting this transferring of water rights.

Wes Thompson-requesting help with the legal side asking Commission help with this protest of water rights. Annette Alvarez- Secretary of the Pecos Water Ditch Association also requesting support from the County Commissioners to protest against the Acequia Water Rights.

Andrea La Cruz Crawford-Attorney representing the Acequias Association, this is the second transfer off of that property loss of cultural practice when the water rights are transferred they still obtain the same water rights 1,700 water rights seniority better rights over their neighbors. Requesting County gets involved with the State Engineer since they have failed to receive public welfare,

Ralph Lambach-there is no amount of monitoring of the water rights. These men have failed to follow legal issues for running a business. Mr. Lambach strongly urges the County Commissioners to support this protest.
